Forbidden intersections for codes

Abstract

Determining the maximum size of a t -intersecting code in $[m]^n$ was a longstanding open problem of Frankl and Füredi, solved independently by Ahlswede and Khachatrian and by Frankl and Tokushige. We extend their result to the setting of forbidden intersections, by showing that for any $m > 2$ and *n* large compared with *t* (but not necessarily m) that the same bound holds for codes with the weaker property of being $(t - 1)$ -avoiding, that is, having no two vectors that agree on exactly $t-1$ coordinates. Our proof proceeds via a junta approximation result of independent interest, which we prove via a development of our recent theory of global hypercontractivity: we show that any $(t - 1)$ -avoiding code is approximately contained in a t -intersecting junta (a code where membership is determined by a constant number of coordinates). In particular, when $t = 1$, this gives an alternative proof of a recent result of Eberhard, Kahn, Narayanan and Spirkl that symmetric intersecting codes in $[m]^n$ have size $o(m^n)$.

1 INTRODUCTION

Many intersection problems for finite sets (see the survey [\[13\]](#page-45-0)) have natural generalisations to a setting variously described as codes, vectors or integer sequences. For example, any intersecting family of subsets of [n] has size at most 2^{n-1} , and more generally, any intersecting code in $[m]^n$ has

size at most m^{n-1} , where we say that a code $\mathcal{F} \subset [m]^n$ is intersecting if for any x, y in \mathcal{F} , there is some *i* with $x_i = y_i$. However, these settings are quite different, in that there are many maximum intersecting families of sets, including very symmetric examples such as the family of all sets of size > $n/2$, whereas in $[m]^n$ for $m > 2$, the only example is obtained by fixing one coordinate to have a fixed value. A more substantial difference was recently demonstrated by Eberhard, Kahn, Narayanan and Spirkl [\[5\]](#page-45-0), who showed that adding a symmetry assumption reduces the maximum size to $o(m^n)$.

A longstanding open problem of Frankl and Füredi [\[9\]](#page-45-0) posed the corresponding question for codes $\mathcal{F} \subset [m]^n$ that are *t*-intersecting, in that any x, y in \mathcal{F} have agreementagr $(x, y) = |\{i : x_i =$ $|y_i\rangle \geq t$. From the perspective of coding theory, one may think of such F as an 'anti-code', in that we are imposing an upper bound on the Hamming distance between any two of its vectors. From a combinatorial perspective, the natural analogy is with t -intersecting k -graphs (k -uniform hypergraphs), for which the extremal question was also a longstanding open problem, posed by Erdős, Ko and Rado [\[8\]](#page-45-0) and finally resolved by the Complete Intersection Theorem of Ahlswede and Khachatrian [\[1\]](#page-45-0). The analogous result for codes, resolving the problem of Frankl and Füredi, was also obtained by Ahlswede and Khachatrian [\[2\]](#page-45-0), and independently by Frankl and Tokushige [\[12\]](#page-45-0). They showed that the maximum size of a *t*-intersecting code in $[m]^n$ is achieved by one of the following natural examples, which can be thought of as Hamming balls on a subset of the coordinates, and which we will simply call 'balls' (following [\[28\]](#page-46-0)): let

$$
S_{t,r}[m]^n = \{x \in [m]^n : |\{j \in [1, t+2r] : x_j = 1\}| \geq t + r\}.
$$

We show for any $m > 2$ and n large compared with t (but not necessarily m) that the same conclusion holds under the weaker assumption that $\mathcal F$ is $(t-1)$ *-avoiding*, that is, no x, y in $\mathcal F$ have agreement $t-1$.

Theorem 1.1. *For all* $t \in \mathbb{N}$ *, there is* $n_0 \in \mathbb{N}$ *such that if* $\mathcal{F} \subset [m]^n$ *is a* $(t-1)$ *-avoiding code with* $m \geq 3$ and $n \geq n_0$, then $|F| \leq \max_{r \geq 0} |S_{t,r}[m]^n|$ with equality only when F is isomorphic to a ball.

Theorem 1.1 can be viewed as an analogue for codes of the classical forbidden intersection problem for set systems, which has a substantial literature, particularly stemming from the many applications of the celebrated Frankl–Rödl theorem [\[11\]](#page-45-0) (see also [\[10, 17\]](#page-45-0)). Our proof (discussed in the next subsection) proceeds via a junta approximation result of independent interest, showing that any $(t - 1)$ -avoiding code is approximately contained in a *t*-intersecting junta (a code where membership is determined by a constant number of coordinates). In particular, when $t=1$, this gives an alternative proof of the result of $[5]$, as a family that essentially depends on few coordinates is very far from being symmetric.

1.1 Overview of the proof

The proof of Theorem 1.1 has three steps, each of which has elements of independent interest.

- (1) Junta approximation: any $(t 1)$ -avoiding code is approximately contained in a t-intersecting junta.
- (2) Anticode stability: a stability version of the Ahlswede–Khachatrian theorem on anticodes determines the structure of the junta from (1) — it must be a certain ball \mathcal{F} .

(3) Bootstrapping: given that the code of maximum size is close to \mathcal{F} , it must in fact be equal to $\mathcal{F}.$

The methods required to implement these three steps depend considerably on the size of m , and we need a variety of ideas in Combinatorics and Analysis, some of which are new. The most significant new idea in this paper is a random gluing operation, which may be thought of as a natural, more versatile, analogue of the sharp threshold phenomenon from the biased hypercube, as we explain below.

We remark that techniques that go into the proof of Theorem [1.1](#page-1-0) and the various steps above are quite flexible and are useful to study the structure of extremal families with respect to more general classes of forbidden configurations. In particular, in Section [8,](#page-40-0) we establish junta approximation results for a richer class of forbidden configurations (rather than just the configuration consisting of two points that agree on $t-1$ coordinates). Such results are often strong enough to get approximate versions of Theorem [1.1;](#page-1-0) however, nailing down the exact size of an extremal family is a more challenging task that we leave for future research.

Random gluings

Often times, when working over the p-biased Boolean hypercube, that is, $\{0, 1\}^n$ along with the measure $\mu_p(x) = p^{|\{i \in [n] \mid x_i = 1\}|}(1 - p)^{|\{i \in [n] \mid x_i = 0\}|}$, one is interested in studying the structure of a monotone family $E \subset \{0, 1\}^n$ (i.e. a family such that if $x \in E$ and $x \le y$ for all i, then $y \in E$). One monotone family $\mathcal{F} \subseteq \{0,1\}^n$ (i.e. a family such that if $x \in \mathcal{F}$ and $x_i \leq y_i$ for all i, then $y \in \mathcal{F}$). One particularly useful idea is to see how much the measure of the family changes when increasing p , that is, study the behaviour of $\mu_p(\mathcal{F}) = Pr_{x \sim \mu_p}[x \in \mathcal{F}]$ as a function of p. It is easy to see that this is an increasing function of p , and the main point of this idea is that the rate of increase tells us a lot about the structure $\mathcal F$ has. In a nutshell, unless the family $\mathcal F$ has some local, junta-like, structure, this increase must be sharp.† This idea plays significant role is various problems in analysis and extremal combinatorics, but seems to be specific to the cube: one heavily relies on an ordering of $\{0, 1\}^n$ which makes sense with respect to intersection problems, and such orderings do not exist on many other domains, such as $[m]^n$.

Our random gluing operator may be viewed as a natural extension of the above operator to $[m]^n$, which is also potentially more versatile and may be relevant in other domains. Given a $k < m$ and a family $\mathcal{F} \subseteq [m]^n$, we think of shrinking the alphabet (in each coordinate independently) from m to k, by identifying each symbol $\sigma \in [m]$ with a symbol from [k], that is, given such identifications $\pi_i : [m] \to [k]$ for each i, one may consider the family $\mathcal{F}_{\pi} = \{(\pi_1(x_1), ..., \pi_n(x_n)) | x \in \mathcal{F}\}\.$ It is clear that such operation is 'friendly' with respect to intersection problems (e.g. if $\mathcal F$ is t intersecting, then so is \mathcal{F}_{π}). We show that this operation, when sampling π_1, \ldots, π_n appropriately and considering an appropriate product measure on $[k]^n$, also enjoys the second effect of the 'increasing p ' idea from above. Namely, we show that unless $\mathcal F$ has local structure (i.e. if $\mathcal F$ is global as per Definition [5.2\)](#page-18-0), one can find a gluing operation that increases the measure of $\mathcal F$ significantly.

The analysis of this gluing operation proceeds via noise stability and a new hypercontractive inequality in general product spaces, which further extends our recent theory of global hypercontractivity introduced in [\[16\]](#page-45-0). This part of the argument can also be viewed as a development of the Junta Method (see [\[4, 16, 19\]](#page-45-0).)

[†] When p is bounded away from 0 and 1, this structure is simply a junta, but when $p = o(1)$ or $p = 1 - o(1)$, this structure may be more complicated and is not fully understood (some partial results are known [\[14, 16, 22\]](#page-45-0)). The notion of 'local structure' in this case considered herein corresponds to having restrictions of the family $\mathcal F$ with significant measure.

The following is a precise statement of our junta approximation theorem, which is a stability theorem of independent interest, describing the approximate structure of any $(t - 1)$ -avoiding code with size that is within a constant factor of the maximum possible.

Theorem 1.2. *For every* $t \in \mathbb{N}$ *and* $\eta > 0$ *, there are* n_0 *and J* in \mathbb{N} *such that if* $\mathcal{F} \subset [m]^n$ *is a* (t – 1)*-avoiding code with* $m \geq 3$ *and* $n \geq n_0$, then there is a *t*-intersecting *J*-junta $\mathcal{J} \subset [m]^n$ such that $|F \setminus J| \leq \eta |J|.$

As mentioned above, Theorem 1.2 implies the result of [\[5\]](#page-45-0), as a junta is far from being symmetric. The assumption $m \geq 3$ is necessary, as when $m = 2$, we have symmetric examples as mentioned above. When $m > m_0(t)$ is large, we will in fact obtain a more precise statement: J will be a subcube of co-dimension t and we will give effective estimates for the approximation parameter η (see Theorems [6.3](#page-29-0) and [7.14\)](#page-38-0).

Our first ingredient in the proof of Theorem 1.2 is a regularity lemma, showing that any code can be approximately decomposed into a constant number of pieces, each of which is pseudorandom, in a certain sense that depends on the size of m. When $m < m_0(t)$ is fixed and $n > n_0(t, m)$ is large, each piece is such that constant size restrictions cannot significantly affect the measure. This is a strong pseudorandomness condition, from which the proof can be completed fairly easily using a result of Mossel on Markov chains hitting pseudorandom sets [\[24\]](#page-46-0). The idea is that if two restrictions defining the regularity decomposition agree in fewer than t coordinates, then we can impose a further restriction to make them agree in exactly $t-1$ coordinates, with no significant loss in measure by pseudorandomness. If our code is $(t - 1)$ -avoiding these restrictions must be cross intersecting, but Mossel's result implies that this is impossible for pseudorandom codes of non-negligible measure.

When *is large, one cannot obtain such a strong pseudorandomness condition in a regularity* lemma, so we settle for the weaker property of uncapturability. A family $\mathcal{F} \subseteq [m]^n$ is said to be uncapturable if it is not approximately contained in a union of constantly many 'dictatorships', that is, families of the form $D_{i\to i} = \{x \in [m]^n | x_i = j\}$ for $i \in [n]$ and $j \in [m]$. We stress here that m is not thought of as constant, so one cannot fix *i* and take $D_{i\to j}$ for all $j \in [m]$. Our regularity lemma in this case shows that any given family $\mathcal F$ may be decomposed into pieces, such that each piece is uncapturable. This weaker regularity lemma makes it significantly harder to establish the t -intersection property as outlined above in the case that m is fixed; the main issue is that uncapturability may not be preserved by further restrictions.

Furthermore, if m is 'huge' (by which we will mean exponential in n), then the cross-agreement statement used for fixed m is false. To see this, consider the codes $\mathcal E$ having all vectors with all coordinates even, and $\mathcal O$ having all vectors with all coordinates odd. There is no non-zero agreement between $\mathcal E$ and $\mathcal O$, yet they are both highly uncapturable, and have measure 2^{-n} (which is non-negligible when *is huge).*

The above example naturally suggests a further case: we say that m is 'moderate' if it is large but not huge. In this case, the high-level proof strategy is the same as for fixed m , although the required cross-agreement statement for uncapturable codes is difficult to prove, and this is where we need the most significant new ideas of the paper (gluing and global hypercontractivity). On the other hand, when *m* is huge, the above example shows that we need a different proof strategy. Here we draw inspiration from more combinatorial arguments of Keller and Lifshitz [\[19\]](#page-45-0) which we adapt to the setting of codes by thinking of $\mathcal{F} \subset [m]^n$ as an *n*-partite *n*-graph (*n*-uniform hypergraph) with parts of size m . While the high-level strategy is similar to that in [\[19\]](#page-45-0), the implementation is quite

different; for example, the key to bootstrapping in this case turns out to be a subtle application of Shearer's entropy inequality.

We write $S_{n,m,t}$ for a largest family among $\{S_{t,r}[m]^n : r \geq 0\}$. From Theorem [1.2,](#page-3-0) we see that if a $(t-1)$ -avoiding code $F \subset [m]^n$ is at least as large as $S_{n,m,t}$, then it is close to a t-intersecting junta. This raises the stability question for t -intersecting codes, which is the second ingredient in our proof of Theorem [1.1:](#page-1-0) must this junta be close to an extremal family? When m is large compared with t , it is not hard to show that such a junta must be close to a subcube of co-dimension t , that is, the ball S_{t} $[n]^n$. For fixed m, the picture is more complex, and the full range of balls can occur; nevertheless, we are able to establish the required stability version of the Ahlswede–Khachatrian anticode theorem.

Theorem 1.3. *For every* $t \in \mathbb{N}$ *and* $\varepsilon > 0$ *, there is* $\delta > 0$ *such that if* $\mathcal{F} \subset [m]^n$ *is t-intersecting with* $m \geq 3$ *and* $|F| \geq (1 - \delta)|S_{n,m}$, *then* $|F \setminus S| \leq \varepsilon |S|$ for some family *S* which is isomorphic $to S_{n,m,t} = S_{t,r}[m]^n$, where $0 \le r \le t$, and $r = 0$ if $m > t + 1$.

The proof of Theorem 1.3 uses a local stability analysis of the compression operator of Ahlswede and Khachatrian $[2]$, and also the corresponding stability result for *t*-intersecting families in the -biased hypercube obtained by Ellis, Keller and Lifshitz [\[6\]](#page-45-0).

Notation

Throughout the paper, we write $[m] = \{1, ..., m\}$. For any $x, y \in [m]^n$, we write $\arg(x, y) = |\{i \in$ $[n]$: $x_i = y_i$. We often identify a code $F \subset [m]^n$ with its characteristic function $[m]^n \mapsto \{0, 1\}$.

Given $x \in [m]^n$ and $R \subset [n]$, we define $x_R \in [m]^R$ by $(x_R)_i = x_i$. Given disjoint $R, R' \subset [n]$ and $a \in [m]^K$, $a' \in [m]^K$, we sometimes denote their concatenation in $[m]^{\text{R} \cup \text{R}'}$ by $(x_R = a, x_{R'} = a')$.
Given $\alpha \in [m]^R$ for some $R \subset [n]$ we write $F[\alpha] = \{x \in \mathbb{R} : x = \alpha\}$ and $F(\alpha) = \{x \in \mathbb{R} : x = \alpha\}$ Given $\alpha \in [m]^R$ for some $R \subset [n]$, we write $\mathcal{F}[\alpha] = \{x \in \mathcal{F} : x_R = \alpha\}$ and $\mathcal{F}(\alpha) = \{x \in \mathcal{F} : x_R = \alpha\}$

We will deal with various product domains $\Omega = \Omega_1 \times ... \times \Omega_n$, mostly (but not only) with $\Omega =$ $[m]^n$; we reserve μ to denote the uniform distribution over the domain under discussion (which will be clear from context). Part I: Small alphabets

Here we will prove our main result Theorem [1.1](#page-1-0) when the alphabet size m is small, that is, t and m are fixed and $n > n_0(t, m)$ is large. This part of the paper will consist of three sections. In the next section, we prove Theorem [1.1](#page-1-0) for fixed m , assuming three key steps of the proof (those described in the introduction). These steps are then proven as separate theorems in Sections [3](#page-6-0) and [4.](#page-10-0)

We start with the junta approximation, for which the two key ingredients are (i) a regularity lemma, which approximately decomposes any code into pieces which are pseudorandom (in a sense to be made precise below), and (ii) a theorem of Mossel [\[24\]](#page-46-0) on Markov chains hitting pseudorandom sets which implies that we can find a pair of vectors with any fixed agreement between any two pseudorandom families (of non-negligible measure).

In proving the stability version of the Ahlswede–Khachatrian anticode theorem, the first key observation is that for codes that are compressed (in a sense to be defined below), there is a natural transformation of the problem to the p-biased hypercube, where the stability theorem has already been proved by Ellis, Keller and Lifshitz [\[6\]](#page-45-0). This may at first not seem helpful for a general stability result, as compression destroys structure, but in fact we can make a local stability argument, that keeps control of the structure under gradual decompression, and thus deduce the general stability result.

For the bootstrapping step, the main ingredient is a 'cross disagreement' theorem, where given two families F and C, we need to find $x \in F$ and $y \in G$ with $\arg(x, y) = 0$. We need this result in the unbalanced setting with $\mu(F)=1-\alpha$ and $\mu(G)=\beta$, where α and β are small, but α is large compared with β . The idea for overcoming this obstacle is to transform the problem via compressions to the setting of cross-intersecting families \mathcal{F}' and \mathcal{G}' in the p-biased hypercube, where $p = 1/m \le 1/3$. We then move to the uniform (1/2-biased) measure, where by an isoperimetric lemma of Ellis, Keller and Lifshitz $[7]$, the measure of the family corresponding to $\mathcal G$ becomes much larger, so that a trivial bound implies that \mathcal{F}' and \mathcal{G}' cannot be cross-intersecting.

2 PROOF SUMMARY

In this section, we prove Theorem [1.1](#page-1-0) for fixed m assuming the three theorems (junta approximation, anticode stability, bootstrapping) mentioned in the overview above, which we now state formally. The first theorem (junta approximation) proves Theorem [1.2](#page-3-0) when J and n_0 can depend on *m* and replaces the conclusion $|F \setminus J| \leq \eta |J|$ by $\mu(F \setminus J) \leq \eta$, which is an equivalent form when *m* is fixed; it will then remain to prove Theorem [1.2](#page-3-0) for $m > m_0(t, \eta)$ sufficiently large (which we will do in Part [II\)](#page-17-0).

Theorem 2.1. *For every* $\eta > 0$ *and* $t, m \in \mathbb{N}$ *with* $m \geq 3$ *, there are J and* n_0 *in* \mathbb{N} *such that if* $\mathcal{F} \subset \mathbb{N}$ $[m]^n$ is a $(t-1)$ -avoiding code with $n \ge n_0$, then there is a *t*-intersecting *J*-junta $\mathcal{J} \subset [m]^n$ such that $\mu(F \setminus J) \leq \eta$.

The second theorem (anticode stability) is equivalent to Theorem [1.3](#page-4-0) for fixed m and t , as we can bound $\mu(S_{n,m,t})$ below by a constant.

Theorem 2.2. *For every* $t \in \mathbb{N}$ *,* $m \geq 3$ *and* $\epsilon > 0$ *, there is* $\delta > 0$ *such that if* $\mathcal{F} \subset [m]^n$ *is t-intersecting with* $\mu(\mathcal{F}) \ge \mu(\mathcal{S}_{n,m,t}) - \delta$, then $\mu(\mathcal{F} \setminus \mathcal{S}) \le \varepsilon$ for some S which is isomorphic to some $\mathcal{S}_{n,m,t}$ $S_{t,r}[m]^n$, where $0 \le r \le t$, and $r = 0$ if $m > t + 1$.

The third theorem (bootstrapping) is an unbalanced cross disagreement theorem: it considers codes $\mathcal{C}, \mathcal{H} \subset [m]^n$ where H is small and G is almost complete, and finds $x \in \mathcal{F}$ and $y \in \mathcal{G}$ with $agr(x, y) = 0$. We state it in a form that will also be useful later in the case that *m* is moderately large.

Theorem 2.3. *For every* $t \in \mathbb{N}$ and $C > 0$, there is $\varepsilon_0 > 0$ such that if $0 < \varepsilon < \varepsilon_0$ and C , $H \subset [m]^n$ *with* $\mu(\mathcal{H}) = m^{-t} \varepsilon$ and $\mu(\mathcal{G}) > 1 - C \varepsilon$, then $\text{agr}(x, y) = 0$ for some $x \in \mathcal{G}$ and $y \in \mathcal{H}$.

Assuming these theorems, we now prove our main theorem for fixed m : the following is obtained from Theorem [1.1](#page-1-0) by allowing n_0 to depend on m.

Theorem 2.4. *For all* $t \in \mathbb{N}$ *and* $m \geq 3$ *, there is* $n_0 \in \mathbb{N}$ *such that if* $\mathcal{F} \subset [m]^n$ *is* $a(t-1)$ *-avoiding code with* $n \geq n_0$, then $|F| \leq |S_{n,m,t}|$, with equality only when F is isomorphic to a ball.

Proof. Let $0 < n_0^{-1}$, $J^{-1} \ll \delta \ll \epsilon \ll t^{-1}$, m^{-1} . Suppose $\mathcal{F} \subset [m]^n$ is $(t-1)$ -avoiding with $|\mathcal{F}| \ge$

By Theorem [2.1,](#page-5-0) there is a t-intersecting J -junta $\mathcal{J} \subset [m]^n$ such that $\mu(\mathcal{F} \setminus \mathcal{J}) \le \delta$, and so $\mu(\mathcal{J} \cap \mathcal{F}) > \mu(\mathcal{F}) - \delta$. We have $\mu(\mathcal{J}) > \mu(\mathcal{F} \setminus \mathcal{J}) > \mu(\mathcal{S} \setminus \mathcal{J}) - \delta$. By Theorem $\mu(J \cap F) \geq \mu(F) - \delta$. We have $\mu(J) \geq \mu(F) - \mu(F \setminus J) \geq \mu(S_{n,m,l}) - \delta$. By Theorem [2.2](#page-5-0) applied to *J*, there is a copy *S* of $\mu(S_{n,m,t})$ with $\mu(J \setminus S) \le \varepsilon$. As $|F| \ge |S|$, we also have

$$
\xi := \mu(S \setminus F) \leq \mu(F \setminus S).
$$

Combining, we get

$$
0 \leq \xi \leq \mu(\mathcal{F} \setminus \mathcal{S}) \leq \mu(\mathcal{F} \setminus \mathcal{J}) + \mu(\mathcal{J} \setminus \mathcal{S}) \leq \delta + \varepsilon.
$$

Suppose for contradiction that $\xi > 0$. Without loss of generality, for some $r \leq t$, we can write

$$
S = \{x \in [m]^n : |\{i \in [t + 2r] : x_i = 1\}| \ge t + r\}.
$$

By averaging, there is $\alpha \in [m]^{[t+2r]}$ with $|\{i : \alpha_i = 1\}| < t + r$ such that $\mathcal{H} := \mathcal{F}_{[t+2r]\to\alpha}$ has $\mu(\mathcal{H}) \ge \mu(\mathcal{S} \setminus \mathcal{F}) = \xi$. We can fix $\beta \in [m]^{t+2r}$ with $|\{i : \beta_i = 1\}| \ge t + r$ such that $\arg(\alpha, \beta) = t -$ 1. We have $\mu((S \setminus F)_{[t+2r]\to\beta}) \leq m^{t+2r} \mu(S \setminus F) \leq m^{3t} \xi$, so $G := F_{[t+2r]\to\beta}$ has $\mu(G) \geq 1 - m^{3t} \xi$.

By Theorem 2.3, with $C = m^{2t}$ and $m^t \xi$ in place of ε , we find $x \in \mathcal{G}$ and $y \in \mathcal{H}$ with $f(x, y) = 0$. However, this gives (x, y) and $(\mathcal{E} x)$ in \mathcal{F} with $2\pi f(x, y)$ $(\mathcal{E} x) = t - 1$, which is $agr(x, y) = 0$. However, this gives (α, y) and (β, x) in $\mathcal F$ with $agr((\alpha, y), (\beta, x)) = t - 1$, which is a contradiction. a contradiction.

3 JUNTA APPROXIMATION

In this section, we prove the junta approximation theorem for fixed m , that is, Theorem [2.1.](#page-5-0) Our first ingredient is a regularity lemma, showing that any code can be approximately decomposed into a constant number of pieces, each of which is pseudorandom, in the sense that restrictions of constant size do not significantly affect the measure. This regularity lemma is similar in spirit to that in [\[6,](#page-45-0) Theorem 1.7]; we refer the reader to Section 1.2 of their paper for discussion how such results are related to the large literature on regularity lemmas in Combinatorics.

The second ingredient is a result of Mossel [\[24\]](#page-46-0) on Markov chains hitting pseudorandom sets, which implies that any two pseudorandom codes $F, G \subset [m]^n$ of non-negligible measure cannot be cross intersecting, that is, we can find a 'disagreement' $(x, y) \in \mathcal{F} \times \mathcal{G}$ with $\text{agr}(x, y) = 0$. If F is $(t - 1)$ -avoiding, this will imply $\arg(\alpha, \beta) \geq t$ for any pieces $\mathcal{F}_{T \to \alpha}$, $\mathcal{F}_{T \to \beta}$ of the regularity decomposition of $\mathcal F$ that are pseudorandom and of non-negligible measure. Indeed, if we had $\arg(\alpha, \beta) = t - 1 - s$ with $s \ge 0$, then we could arbitrarily fix a further restriction $S \to \gamma$ with

 $|S| = s$ to obtain pseudorandom families $\mathcal{F}_{(T,S)\to(\alpha,\gamma)}$, $\mathcal{F}_{(T,S)\to(\beta,\gamma)}$ that are cross intersecting, which is impossible. Here we are implicitly using the (important) fact that pseudorandomness is preserved by constant size restrictions.

3.1 The pseudorandom code regularity lemma

In this subsection, we prove a regularity lemma which approximately decomposes any code into pieces that are pseudorandom in the sense of the following definition.

Definition 3.1. We say $F \subset [m]^n$ is (r, ε) -pseudorandom if for any $R \subset [n]$ with $|R| \leq r$ and $a \in$ $[m]^R$, we have $|\mu(\mathcal{F}_{R\to q}) - \mu(\mathcal{F})| \leq \varepsilon$.

Lemma 3.2. *For any* $r, m \in \mathbb{N}$ *and* $\varepsilon, \delta > 0$ *, there is* $D \in \mathbb{N}$ *such that for any* $F \subset [m]^n$ *with* $n \ge D$ *, there is* $T \subset [n]$ *with* $|T| \le D$ *such that* $Pr_{a \in [m]^T}[F_{T \to a}]$ *is not* (r, ε) -pseudorandom $] \le \delta$ *.*

Proof. We construct T iteratively. Starting with $T = \emptyset$, we consider at each step the set A of $a \in [m]^T$ for which $\mathcal{F}_{T\to a}$ is not (r, ε) -pseudorandom. For any $a \in A$, we fix $b(a) \in [m]^{\mathbb{R}_a}$ for some $R_a \subset [n]$ with $|R_a| \leq r$ such that $|\mu(\mathcal{F}_{(T,R_a)\to(a,b(a))}) - \mu(\mathcal{F}_{T\to\alpha})| > \varepsilon$. If $\mu(A) \leq \delta$ we are done; $K_a \subset [n]$ with $K_a \in Y$ such that $\mu(Y_{(T,R_a)\to(a,b(a)))} = \mu(Y_{T\to\alpha}) > \varepsilon$. If
otherwise, we replace T by $T_{\text{new}} = T \cup R$ where $R = \bigcup_{a \in A} R_a$ and iterate.

We will argue that this process stops with |T| bounded by some function depending on m, r, δ and ε , but not on n . To do so, we apply a standard 'energy increment' argument to the mean-square density

$$
E(T) = \mathop{\mathbb{E}}_{\mathbf{a} \in [m]^T} \left[\mu(\mathcal{F}_{T \to \mathbf{a}})^2 \right]
$$

Clearly, $E(T) \le 1$ for any $T \subset [n]$, and $E(T_1) \le E(T_2)$ whenever $T_1 \subset T_2$ by Cauchy–Schwarz.

We will show that $E(T)$ increases significantly at each step of the process. Indeed, comparing $E(T_{\text{new}})$ and $E(T)$ term by term, we have

$$
E(T_{\text{new}}) - E(T) = \mathop{\mathbb{E}}_{\mathbf{a} \in [m]^T} \left[\mathop{\mathbb{E}}_{\mathbf{b} \in [m]^R} \left[\mu(\mathcal{F}_{(T,R) \to (\mathbf{a}, \mathbf{b})}) \right]^2 - \mu(\mathcal{F}_{T \to \mathbf{a}})^2 \right] = \mathop{\mathbb{E}}_{\mathbf{a} \in [m]^T} [\text{Var} \, Z_{\mathbf{a}}],
$$

where we consider $Z_a(\mathbf{b}) = \mu(\mathcal{F}_{(T,R)\to (a,\mathbf{b})})$ as a random variable determined by the random choice of $\mathbf{b} \in [m]^R$. We have Var $Z_a \ge 0$ for all a, and for any $a \in A$, we have Var $Z_a \ge m^{-|R_a|} \varepsilon^2 \ge m^{-r} \varepsilon^2$ ع m
2−7−2 i in light of the restriction $R_a \to b(a)$. Therefore, $E(T_{new}) \ge E(T) + \mu(A)m^{-r}\varepsilon^2 \ge E(T) + \delta m^{-r}\varepsilon^2$.
In other words, as long as the process does not terminate, the energy function increases by a

In other words, as long as the process does not terminate, the energy function increases by at least $\delta m^{-r} \varepsilon^2$. As the energy is always at most 1, the process terminates after at most $m^r/\delta \varepsilon^2$ steps. Each restriction adds at most *r* new variables to *T*, so in each step, $|T_{\text{new}}| \le 2^{|T|} \cdot r$, and so, the final size of *T* is bounded by some function of *m*, *r*, δ and ε . final size of T is bounded by some function of m, r, δ and ε .

3.2 Markov chains hitting pseudorandom sets

In this subsection, we discuss a special case of a result of Mossel [\[24\]](#page-46-0) needed for the proof of our junta approximation theorem for small alphabets, which can be formulated in terms of Markov

chains hitting pseudorandom sets. We start by summarising some properties of Markov chains (see [\[21\]](#page-45-0) for an introduction). We will consider finite Markov chains, that is, a sequence of random variables $(X_i)_{i\geq0}$ taking values in a state space S (some finite set) described by a transition matrix T with rows and columns indexed by S, where for any event E determined by $(X_0, ..., X_i)$ with $X_i = x$, we have $\mathbb{P}(X_{i+1} = y \mid X_i = x) = T_{xy}$. We also view T as an averaging operator on functions $f: S \to \mathbb{R}$, corresponding to matrix multiplication when we view f as a vector in \mathbb{R}^S : we have (T f)(x) = $E[f(X_1) | X_0 = x] = \sum_y T_{xy} f(y) = (Tf)_x$.
We will suppose that T is imposedually (for any x.

We will suppose that T is irreducible (for any $x, y \in S$, there is some $k \in \mathbb{N}$ with $T_{xy}^k > 0$), so Area is a unique stationary distribution (a probability distribution y on S such that $yT = y$). The there is a unique stationary distribution (a probability distribution ν on S such that $\nu T = \nu$). The stationary chain is obtained by letting X_0 have distibution ν , and then each X_i has distribution ν . In the stationary chain, we have $\mathbb{P}(X_0 = a, X_1 = b) = P_{ab} := \nu_a T_{ab}$. We say that T is reversible if P is symmetric, that is, $P_{ab} = P_{ba}$ for all $a, b \in S$ (the name corresponds to the observation that the distribution of the stationary chain is invariant under time reversal).

When T is reversible, it defines a self-adjoint operator on $L^2(S, \nu)$, that is, functions $f : S \to \mathbb{R}$ when *I* is reversible, it defines a sen-adjoint operator on *L* (*S*, *v*), that is, functions *J* . *S* $\rightarrow \infty$

$$
(1 - \lambda_*)^2 = \sup{\{\mathbb{E}(Tf)^2 : \mathbb{E}f = 0, \mathbb{E}f^2 = 1\}}.
$$

Now we describe a special case of [\[24,](#page-46-0) Theorem 4.4], and for that, we require a basic setup. Let T be a reversible, irreducible Markov chain acting on $S = [m]$, and consider its tensor power $T^{\otimes n}$ acting on $\Omega = [m]^n$ independently in each coordinate, that is, with transition matrix $T^{\otimes n}_{xy}$ = $\prod_{i=1}^{n} T_{x_i y_i}$. Theorem 3.3. Let T be a reversible Markov chain on [m] with absolute spectral gap $\lambda_* > 0$. *Let* ν denote the stationary measure of $T^{\otimes n}$ and x and y be consecutive random states of the *stationary chain. Then for any* $\mu > 0$, there are $\varepsilon, c > 0$ and $r \in \mathbb{N}$ such that if $\mathcal{F}, \mathcal{G} \subset [m]^n$ are (r, ε) -pseudorandom with $\nu(F)$, $\nu(G) > \mu$, then $\mathbb{P}(x \in F, y \in G) > c$.

For convenience of the reader, we outline below the (standard) derivation of Theorem 3.3 from existing results in the literature.

Deriving Theorem 3.3 from [\[24,](#page-46-0) Theorem 4.4]

Let $B = \{b_1, ..., b_m\}$ be an orthonormal basis for $L^2(S, v)$ consisting of eigenvectors of T. We take b_1 to be the trivial eigenvector, that is, $b_1(s) = 1$ for all $s \in S$, which has eigenvalue 1. We remark that by the spectral gap of T, it follows that the eigenvalue of each b_j for $j \neq 1$ is at most $1 - \lambda_{\ast}$. We will view each b_i as a random variable on (S, ν) , and in this language, we have that $Eb_i b_j = 1_{i=j}$. Using the basis B, we may find a basis for $L^2(S^n, \nu^{\otimes n})$ by tensorizing. Namely, for each $i \in [n]$, we take an independent copy of B, say $b^i = (b^i_j : j \in [m])$, and then our basis is $\mathbf{b} = (\mathbf{b}_{j_1,\dots,j_n})_{j_1,\dots,j_n \in [m]},$
where $\mathbf{b} = \mathbf{\Pi}^n$, by an thus represent our function on O as a multi-linear polynomial where $\mathbf{b}_{j_1,...,j_n} = \prod_{i=1}^n b_{j_i}^i$. This above view allows us to extend the definition of P to ℝ^{mn}. Let x and y be sampled as consecutive random states of the stationary chain for $T^{\otimes n}$, and let $f(\mathbf{b}(x)) = 1_{x \in \mathcal{F}}, g(\mathbf{b}(y)) = 1_{y \in \mathcal{C}}$. Our goal is thus to prove a lower bound on $\mathbb{E}_{x,y}[f(\mathbf{b}(x))g(\mathbf{b}(y))].$ The invariance principles of [23-25] allow one to establish non-trivial lower bounds on this quantity by considering its 'analogue in Gaussian space', provided that f , g are sufficiently random-like.

To be more precise, let us first consider $\mathbf{b}_{j_1,\dots,j_n}(x)$ and $\mathbf{b}_{j'_1,\dots,j'_n}(y)$ where x and y are sampled as consecutive random states of the stationary chain for $T^{\otimes n}$. Thus, $\mathbb{E}b_{j_i}^i(x)b_{j'_i}^{i'}(y)$ is zero unless $i = i'$ and $j_i = j'_i$, and then, it is equal to the eigenvalue λ_{j_i} such that $Tb_{j_i} = \lambda_{j_i}b_{j_i}$. Building on [\[25\]](#page-46-0), Mossel [\[23\]](#page-46-0) showed that for $f, g : [m]^n \to [0, 1]$ with 'small enough influences',[†] one has $\mathbb{E}[f(\mathbf{b}(x)) \cdot g(\mathbf{b}(y))]$ is very close $\mathbb{E}[f(z)\tilde{g}(z')]$. The arguments in [\[24\]](#page-46-0) establish the same statement with the more relaxed condition that f and g are (r s) pseudorandom (the the same statement with the more relaxed condition that f and g are (r, ε) -pseudorandom (the term 'resilient' is used therein). More precisely, Mossel showed that for all $\delta > 0$, there are $r \in \mathbb{N}$ and $\varepsilon > 0$ (also depending on *m* and the spectral gap λ_{*} , which are thought of as constants), such that $|\mathbb{E}[f(\mathbf{b}(x)) \cdot g(\mathbf{b}(y))] - \mathbb{E}[\tilde{f}(z)\tilde{g}(z')]| \le \delta$.

For \tilde{f} , the fact that f has averages at least μ implies, by the invariance principle (i.e. the above with $g = 1$), that \tilde{f} has average at least $\mu/2$; similarly, the average of \tilde{g} is at least $\mu/2$. Thus, E[J (%) *y*(%)

The following result is an immediate consequence of Theorem [3.3,](#page-8-0) applied with the Markov chain T on $[m]$ which at each step moves to a uniformly random state different from the current state (note that $\lambda_* > 0$ when $m \geq 3$, but this fails for $m = 2$).

Theorem 3.4. *For every* $m \geq 3$ *and* $\mu > 0$ *, there are* $\varepsilon, c > 0$ *and* $r \in \mathbb{N}$ *such that if* $F, G \subset$ $[m]^n$ are (r, ε) -pseudorandom with $\mu(F)$, $\mu(G) > \mu$ and (x, y) is a uniformly random pair in $[m]^n \times [m]^n$ with $\text{agr}(x, y) = 0$, then $\mathbb{P}(x \in \mathcal{F}, y \in \mathcal{G}) > c$; in particular, $\text{agr}(x, y) = 0$ for some $(x, y) \in \mathcal{F} \times \mathcal{G}$.

^{\dagger} We omit the definition of 'influences' for now, as we do not need it here, but it will reappear later in a more general context when we discuss our theory of global hypercontractivity.

3.3 Approximation by junta

We conclude this section by proving Theorem [2.1.](#page-5-0)

Proof of Theorem 2.1. Let $t, m \in \mathbb{N}$ with $m \geq 3$ and $\eta > 0$, fix $0 \ll n_0^{-1} \ll D^{-1} \ll r^{-1}, \epsilon \ll 1$ n_0 , t^{-1} , m^{-1} and suppose $F \subset [m]^n$ is $(t - 1)$ -avoiding. By Lemma [3.2,](#page-7-0) we find $T \subset [n]$ with $|T| \le D$
such that such that

$$
\Pr_{\mathbf{a}\in[m]^T} \left[\mathcal{F}_{T\to\mathbf{a}} \text{ is not } (r,\varepsilon) \text{-pseudorandom} \right] \leq \eta/2.
$$

We will show that the required conclusions of the theorem hold for the junta $\mathcal{J} = \{x \in [m]^n | x_T \in$ $J\}$, where

$$
J = \left\{ \alpha \in [m]^T \middle| \mathcal{F}_{T \to \alpha} \text{ is } (r, \varepsilon/2) \text{-pseudorandom and } \mu(\mathcal{F}_{T \to \alpha}) \ge \eta/2 \right\},\
$$

that is, that J is t-intersecting (equivalently, J is t-intersecting) and $\mathcal F$ is approximately contained in $\mathcal{J}.$

To see that J is t-intersecting, suppose for contradiction, we have $\alpha_1, \alpha_2 \in J$ with $\text{agr}(\alpha_1, \alpha_2) =$ $t-1-s$ with $s \ge 0$. Fix $S \subset [n] \setminus T$ of size s and $x \in [m]^S$ arbitrarily, and consider the families

$$
\mathcal{G}_i = \left\{ w \in [m]^{[n] \setminus (T \cup S)} \left| (\alpha_i, x, w) \in \mathcal{F} \right. \right\}
$$

for $i = 1, 2$. By definition of J, both $\mu(G_i) \ge \mu(F_{\alpha_i}) - \varepsilon/2 \ge \eta/3$ and G_i is $(r - t, \varepsilon)$ -pseudorandom.
By Theorem 3.4, we find $(m, m) \in C \times C$, with $\arg(m, m) = 0$. However, this gives (α, x, m) By Theorem [3.4,](#page-9-0) we find $(w_1, w_2) \in G_1 \times G_2$ with $\text{agr}(w_1, w_2) = 0$. However, this gives (α_i, x, w_i) for $i = 1, 2$ in F with agreement $t - 1$, which is a contradiction.

It remains to bound $\mu(F \setminus J) = \sum_{\alpha \notin J} m^{-|T|} \mu(F_{T \to \alpha})$. We partition $[m]^T \setminus J$ into (B_1, B_2)
Let remains to bound $\mu(F \setminus J) = \sum_{\alpha \notin J} m^{-|T|} \mu(F_{T \to \alpha})$. We partition $[m]^T \setminus J$ into (B_1, B_2) where B_1 contains those $\alpha \in [m]^T \setminus J$ with $\mu(\mathcal{F}_{T\to\alpha}) < \eta/2$, and $B_2 = [m]^T \setminus (B_1 \cup J)$. Clearly, the contribution to the sum from $\alpha \in B_1$ is at most $\eta/2$. For $\alpha \in B_2$, we note that $\mathcal{F}_{T \to \alpha}$ is not the contribution to the sum from $\alpha \in B_1$ is at most $\eta/2$, for $\alpha \in B_2$, we note that $\gamma_{T\to\alpha}$ is not $(r, \varepsilon/2)$ -pseudorandom by definition of J , so $\sum_{\alpha \in B_2} m^{-|T|} \mu(\mathcal{F}_{T\to\alpha}) \leq \mu(B_2) < \eta/2$ by choice of Thus, $\mu(F \setminus J) < \eta$.

4 COMPRESSION, STABILITY AND BOOTSTRAPPING

In this section, we prove the anticode stability theorem for fixed m , that is, Theorem [2.2,](#page-5-0) and the bootstrapping result Theorem [2.3.](#page-6-0) Both rely on a compression procedure, introduced by Ahlswede and Khachatrian [\[2\]](#page-45-0), which modifies any code in such a way to use some symbol (say 1) 'as much as possible', while maintaining its size and not reducing its minimum intersection size.

In the first subsection, we will formally define compression and prove some of its well-known properties. In the second subsection, we prove the stability result for compressed codes, by reducing it to the corresponding stability result for t -intersecting families in the biased hypercube obtained by Ellis, Keller and Lifshitz [\[6\]](#page-45-0). We deduce Theorem [2.2](#page-5-0) in the third subsection, via a decompression argument, in which we reverse the compressions while keeping control of structure via a local stability argument. In the final subsection, we prove Theorem [2.3,](#page-6-0) by using compressions to reformulate the problem in terms of cross-intersecting families in the biased hypercube.

4.1 Compression

For any $i \in [n]$ and $j \in [m]$, we define the compression operator $T_{i,i} : [m]^n \to [m]^n$ that replaces j by 1 in coordinate *i* if possible, that is, for $x \in [m]^n$, we let $T_{i,j}(x) = y \in [m]^n$ where $y_r = x_r$ for all $r \neq i$, and $y_i = x_i$ if $x_i \neq j$ or $y_i = 1$ if $x_i = j$. We also define a compression operator, also denoted as $T_{i,j}$, on codes, that replaces any vector x by $T_{i,j}(x)$ unless the latter is already present, that is,

$$
T_{i,j}(\mathcal{F}) = \left\{ x \mid T_{i,j}(x) \in \mathcal{F} \right\} \cup \left\{ T_{i,j}(x) \mid x \in \mathcal{F} \right\}.
$$

We also define $T_i = T_{i,2} \circ T_{i,3} \circ ... \circ T_{i,m}$ for any $i \in n$, and $T = T_1 \circ T_2 \circ ... \circ T_n$. One can think of T as trying to set as many coordinates as possible equal to 1. We call $\mathcal{F} \subset [m]^n$ compressed if $T(\mathcal{F}) = \mathcal{F}$.

We need the following well-known facts about these compression operators.

Fact 4.1. Let $F, G \subset [m]^n, i \in [n]$ and $j \in [m]$.

- (1) *We have* $\mu(T(\mathcal{F})) = \mu(T_{i,j}(\mathcal{F})) = \mu(\mathcal{F})$ *.*
- (2) *The family* $T(F)$ *is compressed.*
- (3) If F, G are cross *t*-intersecting, then so are $T_{i,j}(F)$ and $T_{i,j}(G)$, and so are $T(F)$ and $T(G)$. *Furthermore, any* $x \in T(F)$, $y \in T(G)$ *have at least t common coordinates equal to 1.*

Proof. We begin with the first item. Assume without loss of generality that $i = 1$. To see that $\mu(T_{i,j}(F)) = \mu(F)$, we consider any $x \in [m]^{n-1}$, note that vectors (a, x) with $a \in [m] \setminus \{1, j\}$ are unaffected by $T_{i,j}$, and that $T_{i,j}(\mathcal{F})$ and $\mathcal F$ contain the same number of elements of {(1, x), (j, x)}. By iterating, we deduce $\mu(T(\mathcal{F})) = \mu(\mathcal{F})$.

Now we address the second item. Say that F is *i*-compressed for some *i* if whenever $x \in T_i$ F has $x_i = j \neq 1$, we have $T_{i,i}x \in \mathcal{F}$. We first claim that $T_i\mathcal{F}$ is *i*-compressed for each *i*. Indeed, as $T_i \mathcal{F} = T_{i,2} \circ ... \circ T_{i,n} \mathcal{F}$, it follows that either $T_{i,j} \mathcal{F} \in \mathcal{F}$ and then we are done, or else there is $j' < j$ such that F contains the point y that only differs from x in coordinate i and has $y_i = j'$.
In that case $T - y = T - x$ would be in TF so again the claim holds. In that case, $T_{i,i}y = T_{i,i}x$ would be in $T_i \mathcal{F}$, so again the claim holds.

Next, we argue that if F is i-compressed, then T_i F is still i-compressed. To see this, we consider any $x \in T_i \circ T_{i'} \mathcal{F}$ with $x_i = j \neq 1$ and show that $T_{i,j} x \in T_{i'} \mathcal{F}$. We note that $x \in T_{i'} \mathcal{F}$ and consider two cases.

- (a) If $x_{i'} = j' \neq 1$, then x must be in F and as F is *i*-compressed, we get that $T_{i,i}$ $x \in F$; also, as $x \in T_i$, we get that $T_{i',i'}$, $x \in \mathcal{F}$, and as $\mathcal F$ is *i*-compressed, it follows that $T_{i,i} \circ T_{i',i'}$, $x \in \mathcal{F}$. Letting $y = T_{i,i}x$, we see that y and $T_{i',i'}y = T_{i,i} \circ T_{i',i'}x$ are both in F, and so $y \in T_{i'}F$.
- (b) If $x_{i'} = 1$, then there is $j' \ge 1$ such that for the point y that is the same as x on all coordinates except for $y_i = j'$, we have $y \in \mathcal{F}$. As \mathcal{F} is *i*-compressed, we get that $T_{i,j}y \in \mathcal{F}$, and so $T_{i,j} \in \mathcal{F}$, $y \in \mathcal{F}$. Noting that $T_{i,j} \in \mathcal{F}$, $y \in \mathcal{F}$, $y \in \mathcal{F}$, $y \in \mathcal{F}$, $y \in \mathcal{$ $T_{i',i'} \circ T_{i,i} y \in T_{i'} \mathcal{F}$. Noting that $T_{i',i'} \circ T_{i,i} y = T_{i,i} x$, we conclude that $T_{i,i} x \in T_{i'} \mathcal{F}$.

It follows that the family $T\mathcal{F}$ is *i*-compressed for all $i \in [n]$. To conclude, we claim that $T_i \circ T(\mathcal{F}) =$ $T(F)$, which readily implies the second item. Indeed, if $x \in T_i \circ T(F)$, then letting $j = x_i$, if $j \neq j$ 1, then $x \in T(\mathcal{F})$. If $j = 1$, then there is $j' \ge 1$ such that $T(\mathcal{F})$ contains the point y that is the same as x except for $y_i = j'$. As $T(F)$ is *i*-compressed, $x = T_{i,j'} y \in T(F)$. Overall, $T_i \circ T(F) \subseteq T(F)$.
Combining with the first item it follows that the two families are equal Combining with the first item, it follows that the two families are equal.

We now move on to the third item, and suppose for contradiction that F, G are cross tintersecting but $T_{1,i}(\mathcal{F})$ and $T_{1,i}(\mathcal{G})$ are not. Then there are $(a, x) \in T_{i,i}(\mathcal{F})$ and $(b, y) \in T_{i,i}(\mathcal{G})$ with $\arg((a, x), (b, y)) < t$. As F, G are cross t-intersecting, we cannot have both $(a, x) \in F$ and $(b, y) \in \mathcal{G}$, so without loss of generality, $(a, x) = (1, x)$ was obtained from $(j, x) \in \mathcal{F}$. We must have $(b, y) \in G$, as otherwise $(b, y) = (1, y)$ was obtained from $(j, y) \in G$, but then $(j, x) \in F$ and $(j, y) \in \mathcal{G}$ with $\text{agr}((j, x), (j, y)) = \text{agr}((1, x), (1, y)) < t$, contradiction. As $(j, x) \in \mathcal{F}$ and $(b, y) \in \mathcal{G}$ $\mathcal G$, we have agr($(j, x), (b, y) \geq t$, so $b = j$. As $(b, y) \in T_{i,j}(\mathcal G)$, we must have $(1, y) \in \mathcal G$. But now agr((*j*, *x*), (1, *y*)) < *t* gives a contradiction. Thus, $T_{1,j}(\mathcal{F})$ and $T_{1,j}(\mathcal{G})$ are cross *t*-intersecting. By iterating, so are $T(F)$ and $T(G)$.

Finally, suppose for contradiction that $x \in T(F)$, $y \in T(G)$ have fewer than t common coordinates equal to 1. Let x' be obtained from x by setting $x'_i = 1$ if $x_i = y_i \neq 1$ or $x'_i = x_i$ otherwise.
Then $x' \in T(F)$ but x' and y only agree on coordinates i with $x_i = y_i = 1$ which contradicts $T(F)$ Then $x' \in T(F)$ but x' and y only agree on coordinates i with $x_i = y_i = 1$, which contradicts $T(F)$ and $T(G)$ being cross t -intersecting. and $T(G)$ being cross t-intersecting.

Next, we will define a transformation from compressed codes in $[m]^n$ to monotone[†] families in the cube $\{0, 1\}^n$ that preserves minimum (cross) intersection size, and does not decrease the measure when we adopt the p-biased measure on the cube with $p = 1/m$ (as we will do throughout this section).

Definition 4.2. We define $h: [m] \rightarrow \{0, 1\}$ by $h(1) = 1$ and $h(a) = 0$ for all $a \neq 1$, and $h^{\otimes n}$: $[m]^n \to \{0,1\}^n$ by $h^{\otimes n}(x) = (h(x_1),...,h(x_n))$. For any $\mathcal{F} \subset [m]^n$, we let $\widetilde{\mathcal{F}} = h^{\otimes n}(\mathcal{F}) \subset$ ${0, 1}^n$.

Fact 4.3. *Suppose* $F, G \subset [m]^n$ *are compressed.*

- (1) *The family* \widetilde{F} *is monotone and* $\mu_p(\widetilde{F}) \ge \mu(F)$ *.*
- (2) If $\tilde{\mathcal{F}}$ is *t*-intersecting, then so is $\tilde{\mathcal{F}}$.
- (3) If F, G are cross *t*-intersecting, then so are \widetilde{F} , \widetilde{G} .

Proof. The intersection statements are immediate from the final part of Fact [4.1.](#page-11-0) For monotonicity, consider any $\tilde{x} \in \tilde{\mathcal{F}}$ and $\tilde{y} \geq \tilde{x}$. Fix $x \in \mathcal{F}$ with $h^{\otimes n}(x) = \tilde{x}$, that is, $x_i = 1$ if and only if $\tilde{x}_i = 1$. Define $y \in [m]^n$ by $y_i = 1$ if $\tilde{y}_i = 1 \neq \tilde{x}_i$ or $y_i = x_i$ otherwise. Then $y \in \mathcal{F}$, as \mathcal{F} is compressed, and $h^{\otimes n}(y) = \tilde{y}$, so $\tilde{y} \in \tilde{\mathcal{F}}$.

To show $\mu_p(\widetilde{F}) \ge \mu(F)$, we consider intermediate product spaces $\{0, 1\}^r \times [m]^{n-r}$ with the measure $v_r = \mu_p^r \times \mu$, and intermediate families $\mathcal{F}_r = (h^{\otimes r} \otimes I^{\otimes n-r})(T(\mathcal{F}))$ for any $r \ge 0$. It suffices to show $v = (F \cup \ge v(\mathcal{F}))$ for any $r > 0$. We can write show $\nu_{r+1}(\overline{F}_{r+1}) \ge \nu_r(\overline{F}_r)$ for any $r \ge 0$. We can write

$$
\nu_{r+1}(\mathcal{F}_{r+1}) - \nu_r(\mathcal{F}_r) = \sum_{x \in \{0,1\}^r, y \in [m]^{n-r-1}} \mu_p(x) m^{-(n-r-1)} (\mu_p(B_{x,y,r}) - |A_{x,y,r}|/m),
$$

where for $0 \le r \le n$ and $x \in \{0, 1\}^r$, $y \in [m]^{n-r-1}$, we define

$$
A_{x,y,r} = \left\{ a \in [m] \mid (x,a,y) \in \mathcal{F}_r \right\}, \qquad B_{x,y,r} = \left\{ a \in \{0,1\} \mid (x,a,y) \in \mathcal{F}_{r+1} \right\}
$$

Thus, it suffices to show $\mu_p(B_{x,y,r}) \ge \frac{|A_{x,y,r}|}{m}$ for all x, y . To see this, suppose first that $|A_{x,y,r}| =$
1. As *F* is compressed, we have $A_{x,y,r} = \{1\}$, so $B_{x,y,r} = h(A_{x,y,r}) = \{1\}$ and $\mu_p(B_{x,y,r}) = p =$ 1. As *F* is compressed, we have $A_{x,y,r} = \{1\}$, so $B_{x,y,r} = h(A_{x,y,r}) = \{1\}$ and $\mu_p(B_{x,y,r}) = p =$

[†] We call $\mathcal{A} \subset \{0,1\}^n$ monotone if $y \in \mathcal{G}$ whenever $x \in \mathcal{G}$ and $x \leq y$ coordinatewise.

 $|A_{x,y,r}|/m$. Otherwise, if $|A_{x,y,r}| \ge 2$, we have $B_{x,y,r} = h(A_{x,y,r}) = \{0,1\}$, so $\mu_p(B_{x,y,r}) = 1 \ge |A_{x,y,r}|/m$. □ $|A_{x,y,r}|/m$. □

4.2 Stability when compressed

In this subsection, we prove Theorem [2.2](#page-5-0) for compressed families, using the corresponding stability result for *t*-intersecting families in the biased hypercube obtained by Ellis, Keller and Lifshitz [\[6\]](#page-45-0), which we start by stating. Given *n*, *p*, *t*, let $S_{n,n}$ denote a family S_{t} {0, 1}^{*n*} \subset {0, 1}^{*n*} with the largest p-biased measure, where $r = 0, 1, ..., t - 1$ and

$$
S_{t,r}\{0,1\}^n = \{x \in \{0,1\}^n : |\{i \in [t+2r] : x_i = 1\}| \geq t + r\}.
$$

The following is implied by [\[6,](#page-45-0) Theorem 1.10]. \dagger

Theorem 4.4. *For every* $t \in \mathbb{N}$, $\zeta > 0$ *and* $\varepsilon > 0$ *, there is* $\delta > 0$ *such that if* $\mathcal{F} \subset \{0, 1\}^n$ *is* t *intersecting,* $\zeta \le p \le \frac{1}{2} - \zeta$ and $\mu_p(\mathcal{F}) \ge (1 - \delta)\mu(S_{n, p, t})$, then $\mu_p(\mathcal{F} \setminus S) \le \varepsilon \mu(S)$ for some copy S
of S_n = S_n {0, 1}ⁿ where 0 < r < t if p < 1 /2, and r = 0 if p < ¹ $\int_{r_1, r_2}^{r_3} \int_{r_1, r_2}^{r_2} f(t, t) dt$, where $0 \le r \le t$ if $p \le 1/3$, and $r = 0$ if $p \le \frac{1}{t+1} - \zeta$.

Using Theorem 4.4, we can prove a weaker version of Theorem [2.2,](#page-5-0) with the additional assumption that $\mathcal F$ is compressed. This version will be used in the next subsection to prove Theorem [2.2](#page-5-0) as stated.

Claim 4.5. For every $t \in \mathbb{N}$, $m \geq 3$ and $\varepsilon > 0$, there is $\delta > 0$ such that if $\mathcal{F} \subset [m]^n$ is compressed and *t*-intersecting with $\mu(F) \geq (1 - \delta)\mu(S_{n,m,t})$, then $\mu(F \setminus S) \leq \varepsilon \mu(S)$ for some copy S of $S_{n,m,t}$ $S_{t,r}[m]^n$, where $0 \le r \le t$, and $r=0$ if $m>t+1$.

Proof. Suppose $\mathcal{F} \subset [m]^n$ is compressed and *t*-intersecting with $\mu(\mathcal{F}) \geq (1 - \delta)\mu(S_{n,m})$, where $\delta \ll m^{-1}, t^{-1}, \epsilon$. We consider $\widetilde{\mathcal{F}}$ ⊂ {0, 1}ⁿ given by Definition [4.2.](#page-12-0) By Fact [4.3,](#page-12-0) $\widetilde{\mathcal{F}}$ is *t*-intersecting, and $\mu_p(\tilde{F}) \ge \mu(F) \ge (1 - \delta)\mu(S_{n,m,t}) = (1 - \delta)\mu_p(S_{n,p,t})$, where $p = 1/m$. By Theorem 4.4, we have $\mu_p(\mathcal{F} \setminus \widetilde{S}) \le \varepsilon \mu(\widetilde{S})$ for some copy \widetilde{S} of $S_{n,p,t} = S_{t,r} \{0, 1\}^n$, where $0 \le r \le t$ (as $p = 1/m \le$ 1/3) and $r = 0$ if $m > t + 1$ (taking $\zeta < \frac{1}{t+1} - \frac{1}{t+2}$).
We show that the conclusion of the claim holds

We show that the conclusion of the claim holds for $S = \{x : h^{\otimes n}(x) \in \widetilde{S}\}$, where $h : [m]^n \to$ ${0, 1}^n$ is as in Definition [4.2.](#page-12-0) To see this, first note that S is a copy of $S_{n,m,t}$. Furthermore, if $x \in \mathcal{F} \setminus \mathcal{S}$, then $h(x) \in \tilde{\mathcal{F}} \setminus \tilde{\mathcal{S}}$, and if x is uniformly random in $[m]^n$, then $h^{\otimes n}(x)$ is distributed as μ_p , so

$$
\Pr_{x \in [m]^n} [x \in \mathcal{F} \setminus S] \le \Pr_{x \in [m]^n} [h^{\otimes n}(x) \in \widetilde{\mathcal{F}} \setminus \widetilde{S}] = \mu_p(\widetilde{\mathcal{F}} \setminus \widetilde{S}) \le \varepsilon \mu_p(\widetilde{S}) = \varepsilon \mu(S).
$$

4.3 Decompression and local stability

In this subsection, we prove Theorem [2.2](#page-5-0) in general, deducing it from the compressed case proved in the previous subsection, and for that, we use decompression and local stability arguments. We

^{\dagger} We state it in a weaker form where we do not specify the exact dependency between parameters, as we do not require this.

start with a proof sketch, where for simplicity, we assume that $m > t + 1$, so that the extremal examples are cubes of co-dimension t .

Suppose $\mathcal{F} \subset [m]^n$ is t-intersecting with size close to the maximum possible. Let $\mathcal{G} = T(\mathcal{F})$ be the compressed form of F. By the previous subsection, G is close to a subcube, say $S = \{x \mid x_1 = 1\}$ $\cdots = x_t = 1$.

We now decompress: we consider how the family changes as we undo the compression operators one by one. First, we note that undoing $T_n, T_{n-1}, \ldots, T_{t+1}$ does not change the distance from S, so $\mathcal{G}_t = T_1 \circ ... \circ T_t(\mathcal{F})$ has the same distance to S as \mathcal{G} .
The main point of the argument is to analyze the effect

The main point of the argument is to analyse the effect of undoing T_i for $i = 1, \dots, t$. For $j \in [m]$, we let α_i be the fraction of \mathcal{G}_{t-1} with prefix $(1^{t-1}, j)$. If there is some j^* with α_{i^*} close to 1, then \mathcal{G}_{t-1} is close to a subcube, and we can continue decompressing. Otherwise, we can partition most
of C into two non-perligible parts such that the value of i in the prefix (1^{t-1} i) always differe of \mathcal{G}_{t-1} into two non-negligible parts such that the value of *j* in the prefix (1^{t-1}, *j*) always differs between the two parts However as $\mathcal F$ is t-intersecting this implies that the two parts must be between the two parts. However, as $\mathcal F$ is *t*-intersecting, this implies that the two parts must be cross-intersecting on the coordinates $[n] \setminus [t]$; this will give a contradiction by the following form of Hoffman's bound (which we will prove later in a more general form, see Lemma [5.9\)](#page-21-0).

Lemma 4.6. *Suppose* $G_1, G_2 \subset [m]^n$ *are cross-intersecting with* $\mu(G_i) = \alpha_i$ *for* $i = 1, 2$ *. Then* $\alpha_1 \alpha_2 \le$ $(1 - \alpha_1)(1 - \alpha_2)/(m - 1)^2$.

We start with a lemma that applies Lemma 4.6 to implement the idea discussed in the previous paragraph. Recall that the largest intersecting codes in $[m]^n$ are the 'dictators' $D_{i\to i} = \{x : x_i = j\}$. We show that if $A, B \subset [m]^n$ have nearly maximum size, are cross-intersecting and $T_i(A), T_i(B) \subset$ $D_{i\rightarrow 1}$, then there is some dictator $D_{i\rightarrow i}$ that essentially contains A and B. Recall that $p = 1/m$ throughout.

Lemma 4.7. *Let* $0 < \varepsilon \le 1/15$ *and* $m \ge 3$ *. Suppose* $A, B \subset [m]^n$ *are cross-intersecting with* $\mu(A), \mu(B) \geq (1 - \varepsilon)p$ and $T_i(A), T_i(B) \subset D_{i \to 1}$. Then there is $j \in [m]$ such that $\mu(A \cap D_{i \rightarrow i}), \mu(B \cap D_{i \rightarrow i}) \geq (1 - 3\varepsilon)p.$

Proof. Without loss of generality, we can assume $i = 1$. As $T_1(\mathcal{A}) \subset D_{1\to 1}$, we can write $T_1(\mathcal{A})$ as the disjoint union over $j \in [m]$ of $\mathcal{A}_j := \{(1, z) : z \in \mathcal{A}_{1 \to j}\}$; in particular, $\mathcal{A}_1, ..., \mathcal{A}_m$ are disjoint. Similarly, we may define $B_1, ..., B_m$ and have that $B_1, ..., B_m$ are disjoint. For each $j \in [m]$, let Similarly, we may define $D_1, ..., D_m$ and have that $D_1, ..., D_m$ are disjoint. For each $j \in [m]$, let $\alpha_j = \mu(A_{1\to j})$ and $\beta_j = \mu(B_{1\to j})$. Then $\sum_j \alpha_j = p^{-1}\mu(A) \ge 1 - \varepsilon$ and $\sum_j \beta_j = p^{-1}\mu(B) \ge 1 - \varepsilon$. We need to show that for some $j \in [m]$, we have $\alpha_j, \beta_j \geq 1 - 3\varepsilon$.

To see this, suppose without loss of generality that $\alpha = \alpha_1$ is largest among ${\{\alpha_i\}}_{i \in [m]} \cup {\{\beta_i\}}_{i \in [m]}$. Let $B_{\neq 1} := \bigcup_{j \in [2,m]} B_j$ and $\beta_{\neq 1} = \mu(B_{\neq 1})$. Then $\beta_{\neq 1} = \sum_{j \neq 1} \beta_j \ge 1 - \varepsilon - \beta_1 \ge 1 - \alpha_1 - \varepsilon$. As A_1
and B_2 are cross-intersecting by Lemma 4.6 we have and $B_{\neq 1}$ are cross-intersecting, by Lemma 4.6, we have

$$
\alpha_1(1-\alpha_1-\varepsilon)\leq \alpha_1\beta_{\neq 1}\leq (1-\alpha_1)(\beta_1+\varepsilon)/(m-1)^2\leq (1-\alpha_1)(\alpha_1+\varepsilon)/(m-1)^2.
$$

Rearranging gives $((m-1)^2-1)\alpha_1(1-\alpha_1) \leq ((m-1)^2\alpha_1+(1-\alpha_1))\epsilon \leq (m-1)^2\epsilon$. Thus, $\alpha_1(1 - \alpha_1) \leq 4\varepsilon/3$, so either $\alpha_1 \leq 3\varepsilon$ or $\alpha_1 \geq 1 - 3\varepsilon$. We will show that the second bound holds.

Suppose otherwise. Then $\alpha_i \leq 3\varepsilon$ for all $j \in [m]$. We can partition $[m]$ as $Q_1 \cup Q_2$ so that for suppose otherwise. Then $a_j \le s \le 1$ of an $j \in [m]$, we can partition $[m]$ as $Q_1 \cup Q_2$ s
 $k = 1, 2$, we have $\sum_{j \in Q_k} \alpha_j \ge (1 - \varepsilon - 3\varepsilon)/2 \ge 1/2 - 2\varepsilon$. Without loss of generality, $\sum_{j \in Q_k} \alpha_j \ge (1 - \varepsilon - 3\varepsilon)/2 \ge 1/2 -$ $\frac{2}{\epsilon}$ 1/2 – ϵ . Then $\cup_{j\in Q_1} B_j$ and $\cup_{j\in Q_2} A_j$ cross-intersect and both have densities at least $1/2 - 2\epsilon$ in $[m]^{n-1}$, which contradicts Lemma 4.6, as $\varepsilon \le 1/15$. Thus, $\alpha_1 \ge 1 - 3\varepsilon$, as required. Now we apply Lemma [4.6](#page-14-0) again to A_1 and $B_{\neq 1}$, which gives $(1 - 3\varepsilon)\beta_{\neq 1} \leq \alpha_1\beta_{\neq 1} \leq (1 - \alpha_1)(1 - \beta_{\neq 1})/(m - 1)^2 \leq$ $\frac{32}{4}$, so $\beta_{\neq 1} \le 2\varepsilon$. As $\beta_1 \ge (1 - \varepsilon) - \beta_{\neq 1}$, this gives $\beta_1 \ge 1 - 3\varepsilon$, completing the proof.

We conclude this subsection with the proof of the stability theorem.

Proof of Theorem 2.2. Let $0 < \delta \ll \varepsilon' \ll \varepsilon, t^{-1}, m^{-1}$. Suppose $\mathcal{F} \subset [m]^n$ is *t*-intersecting with $\mu(F) \geq (1 - \delta)\mu(S_{n,m})$. We can assume without loss of generality that for each $i \in [n]$, the most popular value of x_i for $x \in \mathcal{F}$ is 1 (otherwise we simply relabel the alphabet in that coordinate). We set $\mathcal{F}_0 = F$ and for each $i \in [n]$, let $\mathcal{F}_i = T_i(\mathcal{F}_{i-1})$. By Fact [4.1,](#page-11-0) $\mathcal{F}_n = T(\mathcal{F}_0)$ is *t*-intersecting,
compressed, and $u(\mathcal{F}_1) > (1 - \delta)u(\mathcal{S}_1)$. By Claim 4.5, $u(\mathcal{F}_1) \leq s \leq \epsilon' u(\mathcal{S})$ for some compressed, and $\mu(\mathcal{F}_n) \geq (1 - \delta)\mu(S_{n,m,t})$. By Claim [4.5,](#page-13-0) $\mu(\mathcal{F} \setminus S) \leq \varepsilon' \mu(S)$ for some copy S of $S = S$ [m]ⁿ where $0 \leq r \leq t$ and $r = 0$ if $m > t + 1$. We write I for the set of coordinates on $S_{n,m,t} = S_{t,r}[m]^n$, where $0 \le r \le t$, and $r = 0$ if $m > t + 1$. We write J for the set of coordinates on which it depends so $|I| = t + 2r$ which it depends, so $|J| = t + 2r$.

We define ε_i for all $i \in [n]$ by $\mu(F_i \cap S) = (1 - \varepsilon_i)\mu(S)$. We note that $\mu(F) = \mu(F_n) \leq (1 + \varepsilon_i)$ ع
+1 $(\mathcal{A})\mu(S)$ and $\mu(F_n \cap S) \geq (1 - \varepsilon' - \delta)\mu(S) \geq (1 - 2\varepsilon')\mu(S)$, so $\varepsilon_n \leq 2\varepsilon'$. We will show inductively
not ε is suitably small for $i = n, n - 1, \ldots, 0$. To prove the theorem, it suffices to show $\varepsilon \leq \varepsilon/2$, as that ε_i is suitably small for $i = n, n - 1, ..., 0$. To prove the theorem, it suffices to show $\varepsilon_0 < \varepsilon/2$, as $u(F \setminus S) < u(F) = u(F \cap S) < (1 + \varepsilon)u(S) - (1 - \varepsilon)u(S) < (\varepsilon' + \varepsilon)u(S)$ $\mu(F \setminus S) \le \mu(F) - \mu(F \cap S) \le (1 + \varepsilon')\mu(S) - (1 - \varepsilon_0)\mu(S) \le (\varepsilon' + \varepsilon_0)\mu(S).$
Note that if $i \notin I$ then S is *i*-insensitive meaning that for all $x \in [m]^n$ in

Note that if $i \notin J$, then S is *i*-insensitive, meaning that for all $x \in [m]^n$, membership of x in S does not depend on x_i . For such i, we have $|T_i(G) \cap S| = |G \cap S|$ for any $G \subset [m]^n$, so $\mu(F_{i-1} \cap S)$ $(S) = \mu(F_i \cap S)$, that is, $\varepsilon_i = \varepsilon_{i-1}$. For $i \in J$, we will show that $\varepsilon_{i-1} \leq 3(t+1)^{3t} \varepsilon_i$. This will imply $\varepsilon_0 < (3(t+1)^{3t})^{|J|} \varepsilon' < \varepsilon/2$ as $\varepsilon' \ll \varepsilon$, and so will suffice to complete the proof of the theorem.
Set $I : = I \setminus \{i\}$ Given $v \in [m]^J$ and $D \subset [m]^n$ we use the abbreviation

Set $J_i := J \setminus \{i\}$. Given $y \in [m]^{\bar{j}}$ and $D \subset [m]^n$, we use the abbreviation

$$
\mathcal{D}(y) := \mathcal{D}_{J_i \to y} = \left\{ z \in [m]^{[n] \setminus J_i} \left| (y, z) \in \mathcal{D} \right. \right\} \subset [m]^{[n] \setminus J_i}.
$$

We require the following claim, showing that if two J_i -restrictions $\mathcal{F}_i(y_1)$ and $\mathcal{F}_i(y_2)$ are close to the same *i*-dictator, where y_1, y_2 have agreement at most $t-1$, then this is also true of $\mathcal{F}_{i-1}(y_1)$ and $\mathcal{F}_{i-1}(y_2)$.

Claim 4.8. Suppose $y_1, y_2 \in [m]^{\mathcal{J}_i}$ with $\arg(y_1, y_2) \leq t - 1$ and $\mu(\mathcal{F}_i(y_k) \cap D_{i-1}) \geq (1 - \xi)p$ for both $k = 1, 2$, where $0 \le \xi \le 1/6$. Then there is $j \in [m]$ such that both $\mu(F_{i-1}(y_k) \cap D_{i \to i}) \ge$ $(1-3\xi)p$. Moreover, for any $j' \neq j$, both $\mu(F_{i-1}(y_k) \cap D_{i \to i'}) < (1-3\xi)p$.

Proof. Note that $F_{i-1}(y_1)$ and $F_{i-1}(y_2)$ are cross-intersecting, as F_{i-1} is *t*-intersecting and $\arg(y_1, y_2) \le t - 1$. Let $A_k = \{x \in \mathcal{F}_{i-1}(y_k) : T_i(x) \in \mathcal{F}_i(y_k) \cap D_{i-1}\}$ for $k = 1, 2$. Then A_1, A_2 are cross-intersecting and both $\mu(\mathcal{A}_k) > (1 - \xi)p$, so the existence of j follows from Lemma [4.7.](#page-14-0)

For the 'moreover' part, note that if $j' \neq j$, then $(F_{i-1})_{J \to (v_1,j')}$ and $(F_{i-1})_{J \to (v_2,j)}$ are cross-intersecting, and applying Lemma [4.6](#page-14-0) gives us that $\mu((\mathcal{F}_{i-1})_{J\to(\gamma_1,j')}) < 1-3\xi$. The same argument works interchanging the roles of y_1 and y_2 , and we get that $\mu(F_{i-1}(y_k) \cap D_{i \to j'})$ < (1 − 3ξ) p . $(1-3\xi)p.$

Using Claim 4.8, we now bound ε_{i-1} . We start with the case $r=0$. Let $\mathbf{1} \in [m]^{J_i}$ be the all-1 vector. We have $\mu(F_i(1) \cap D_{i \to 1}) = p^{1-t} \mu(F_i \cap S) = (1 - \varepsilon_i)p$, so by Claim 4.8 with $y_1 = y_2$ **1**, there is $j \in [m]$ such that $\mu(\mathcal{F}_{i-1}(1) \cap D_{i \to i}) \geq (1-3\varepsilon_i)p$. The most popular value in \mathcal{F}_{i-1} of coordinate *i* is 1 (since this is the case in \mathcal{F}), so $j=1$. We deduce $\mu(\mathcal{F}_{i-1}\cap S)=p^{t-1}\mu(\mathcal{F}_{i-1}(1)\cap S)$ $(D_{i\to 1}) \geqslant (1-3\varepsilon_i)p^t$, so $\varepsilon_{i-1} \leqslant 3\varepsilon_i$.

It remains to consider $r \geq 1$. We have $m \leq t + 1$ by Claim [4.5.](#page-13-0) For a vector $y \in [m]^n$ and $j \in [m]$, let y[j] be the set of coordinates of *i* equal to j. We partition *S* as $S = S_0 \cup S_1$, where

$$
S_0 := \{x \in [m]^n : x|_{J_i} \in \mathcal{G}_0\}, \qquad \qquad \mathcal{G}_0 := \{y \in [m]^{J_i} : |y[1]| > t + r - 1\},\
$$

$$
S_1 = \{x \in [m]^n : x|_{J_i} \in \mathcal{G}_1\} \cap D_{i \to 1}, \qquad \qquad \mathcal{G}_1 := \{y \in [m]^{J_i} : |y[1]| = t + r - 1\}.
$$

As S_0 is *i*-insensitive, $\mu(\mathcal{F}_{i-1} \cap S_0) = \mu(\mathcal{F}_i \cap S_0)$. Now we wish to show that $\mu(\mathcal{F}_{i-1} \cap S_1)$ is large, that $\mu(\mathcal{F}_{i-1} \cap S_1) = \mu(\mathcal{F}_i \cap S_0)$. Now we wish to show that $\mu(\mathcal{F}_{i-1} \cap S_1)$ is large, that is, that $\mu(F_{i-1}(y) \cap D_{i-1})$ is close to 1 for each $y \in G_1$. Firstly we show this for \mathcal{F}_i .

Claim 4.9. $\mu(F_i(y) \cap D_{i-1}) \geq (1 - (t+1)^{3t} \varepsilon_i) p$ for each $y \in G_1$.

Proof. To see this, we note that

$$
\varepsilon_i \mu(S) = \mu(S \setminus F_i) \ge \mu(S_1 \setminus F_i) = \sum_{y \in \mathcal{G}_1} p^{|J_i|} (p - \mu(F_i(y) \cap D_{i \to 1})).
$$

Each summand on the right-hand side is non-negative, and $|J| = t + 2r \le 3t$, so for each $y \in G_1$, we have $p - \mu(F_i(y) \cap D_{i-1}) \le p(t+1)^{3t} \varepsilon_i$, so the claim holds. we have $p - \mu(F_i(y) \cap D_{i \to 1}) \leq p(t+1)^{3t} \varepsilon_i$, so the claim holds.

Next, we prove the corresponding claim for \mathcal{F}_{i-1} , although at first just with D_{i-1} for some $j \in$ [m]; the theorem will follow once we show that $j = 1$. We say that $y \in G_1$ is j-good if $\mu(F_{i-1}(y) \cap G_i)$ $D_{i\rightarrow j}$) $\geq 1 - 3(t+1)^{3t} \varepsilon_i$)*p*.

Claim 4.10. There is some $j \in [m]$ such that every $y \in G_1$ is j-good.

Proof. Note that for any $y, y' \in G_1$ with $\arg(y, y') = t - 1$, by Claims [4.8](#page-15-0) and 4.9, there is some $j \in$ $[m]$ such that both y and y' are j-good. The claim then follows from the observation that the graph G whose edges consist of such pairs $\{y, y'\}$ is connected. (We can get between any two elements of C , by a sequence of steps where in each step, we change some coordinate from 1 to another value \mathcal{G}_1 by a sequence of steps where in each step, we change some coordinate from 1 to another value
and some coordinate from another value to 1 and each such step can be implemented by a path and some coordinate from another value to 1, and each such step can be implemented by a path of length two in G .) \Box

It remains to show that $j = 1$. We consider $\mathcal{T} = \mathcal{T}_0 \cup \mathcal{T}_1$, where $\mathcal{T}_0 = \{y \in [m]^n | y_{j_i} \in \mathcal{G}_0\} = \mathcal{S}_0$ and $\mathcal{T}_1 = \{ y \in [m]^n | y_{J_i} \in \mathcal{G}_1, y_i = j \}$. Recalling that $\mu(\mathcal{F}_{i-1} \cap \mathcal{S}_0) = \mu(\mathcal{F}_i \cap \mathcal{S}_0)$, by the previous claim we deduce $\mu(\mathcal{F}_{i-1} \cap \mathcal{F}_1) \leq (1 - 3(t+1)^{3t} \epsilon) \mu(\mathcal{F}_1)$ so claim, we deduce $\mu(\mathcal{F}_{i-1} \cap \mathcal{T}) \geq (1 - 3(t+1)^{3t} \varepsilon_i) \mu(\mathcal{T})$, so

$$
\mu(\mathcal{F}_{i-1} \setminus \mathcal{T}) \leq \mu(\mathcal{F}_{i-1}) - \mu(\mathcal{F}_{i-1} \cap \mathcal{T}) \leq 3(t+1)^{3t} \varepsilon_i + \varepsilon' \leq 4(t+1)^{3t} \varepsilon_i,
$$

where in the second inequality, we used $\mu(F_{i-1}) = \mu(F) \leq (1 + \varepsilon')\mu(S) = (1 + \varepsilon')\mu(T)$. Hence,
for $\ell \neq i$ the fraction of $x \in \mathcal{F}$, such that $x = \ell$ is at most $4(\ell + 1)^{3\ell} \varepsilon + a(\ell)$ where $a(\ell)$ is the for $\ell \neq j$, the fraction of $x \in \mathcal{F}_{i-1}$ such that $x_i = \ell$ is at most $4(t+1)^{3t} \varepsilon_i + q(\ell)$, where $q(\ell)$ is the fraction of $x \in \mathcal{T}$ that have $x_i = \ell$; by symmetry, this value is the same for all $\ell \neq j$, and we denote it by q. The fraction of $x \in \mathcal{F}_{i-1}$ such that $x_i = j$ is, for the same reasons, at least $q(j) - 4(t+1)^{3t} \varepsilon_i$. But $q(j) \ge q + \mu(G_1) \ge q + (t+1)^{-3t}$, so $q(j) - 4(t+1)^{3t} \varepsilon_i \ge q + 4(t+1)^{3t} \varepsilon_i$ (we can ensure $\varepsilon_i < 1/8$). Thus, *i* is the most popular value of coordinate *i* in \mathcal{F}_{i+1} , so $i = 1$, as required. 1/8). Thus, *j* is the most popular value of coordinate *i* in \mathcal{F}_{i-1} , so $j = 1$, as required.

4.4 Bootstrapping

We conclude this part by proving Theorem [2.3,](#page-6-0) which completes the proof of Theorem [2.4.](#page-6-0) We will use compressions to reduce to the cube, so we start with some remarks in this setting.

We consider ${0, 1}^n$ equipped with the uniform measure μ . Suppose $\mathcal{A}, \mathcal{B} \subset \{0, 1\}^n$. We say that A, B are cross-intersecting if for any $x \in A$, $y \in B$, there is $i \in [n]$ such that $x_i = y_i = 1$. We say that A, B are cross-agreeing if for any $x \in A$, $y \in B$, there is $i \in [n]$ such that $x_i = y_i$. Clearly, if A, B are cross-intersecting, then they are cross-agreeing. We have the following easy fact, which is immediate from the observation that if A, B are cross-agreeing and $x + y = 1$ (the all-1 vector), then we cannot have $x \in A$ and $y \in B$.

Fact 4.11. *If* $A, B \subset \{0, 1\}^n$ are cross-agreeing, then $\mu(A) + \mu(B) \le 1$.

We also require the following isoperimetric lemma of Ellis, Keller and Lifshitz [\[7\]](#page-45-0).

Lemma 4.12. *Suppose* $0 \le p \le q \le 1$, $\alpha \ge 0$ *and* $F \subset \{0, 1\}^n$ *is monotone. If* $\mu_n(F) \ge p^\alpha$ *, then* $\mu_q(\mathcal{F}) \geq q^{\alpha}$.

Proof of Theorem 2.3. Let $G, H \subset [m]^n$ with $\mu(H) = m^{-t} \varepsilon$ and $\mu(G) > 1 - C \varepsilon$, where $0 \ll \varepsilon \ll$ t^{-1} , C^{-1} . Suppose for contradiction that G and H are cross-agreeing. Let $G' = T(G)$ and $H' = T(H)$, where T is the compression operator and the operator $\mathcal{F} \to \widetilde{\mathcal{F}}$ is from Definition [4.2.](#page-12-0) By Facts [4.1](#page-11-0) and [4.3,](#page-12-0) G' and H' are monotone and cross-intersecting with $\mu_p(G') \ge \mu(G)$ and $\mu_p(H') \ge \mu(H)$,
where $n = 1/m$ where $p = 1/m$.

Now we consider \mathcal{G}' and \mathcal{H}' under the uniform measure $\mu = \mu_{1/2}$. By monotonicity, we have $\mu(G') \ge \mu_p(G') > 1 - C\epsilon$. By Lemma 4.12, $\mu(H') \ge \mu_p(H')^{\log_p(1/2)}$, so $\log_2 \mu(H')$
log $(m^{-1}\epsilon)/\log(m)$ giving $\mu(H') > 2^{-t} \epsilon^{0.7}$ as $m > 3$ and $1/\log(3) < 0.7$ However $1 - C$ $\log_2(m^{-t}\varepsilon)/\log_2(m)$, giving $\mu(H') \geq 2^{-t}\varepsilon^{0.7}$, as $m \geq 3$ and $1/\log_2(3) < 0.7$. However, $1 - C\varepsilon + 2^{-t}\varepsilon^{0.7} > 1$ as $\varepsilon \ll t^{-1}$, which contradicts East 4.11 $2^{-t} \varepsilon^{0.7} > 1$ as $\varepsilon \ll t^{-1}$, C^{-1} , which contradicts Fact 4.11.

Part II: Moderate alphabets

In this part, we prove our main result Theorem [1.1](#page-1-0) when the alphabet size m is moderate, that is, $m_0(t) \le m \le 2^{n/N(t)}$. Here the largest *t*-intersecting codes are subcubes of codimension *t*. As mentioned in the introduction, we cannot achieve such a strong pseudorandomness condition in our regularity lemma as in the case of fixed m , so we settle for a weaker notion of 'uncapturability'. We present the proof in the second section of the part, where to implement a version of the cross-agreement strategy, we introduce a gluing argument that exploits expansion under another pseudorandomness condition, namely globalness. The tools for this are developed in the first section, in which we study our two pseudorandomness conditions (uncapturability and globalness) and establish the small-set expansion for global functions via a refined version of our global hypercontractivity inequality from [\[16\]](#page-45-0).

5 TOOLS

This section concerns various properties of the pseudorandomness notions of uncapturability and globalness, particularly a regularity lemma for uncapturability and a small set expansion

property for global functions, which is analogous to Theorem [3.3.](#page-8-0) The latter will be established via a corresponding statement for the noise operator, which will be proved by a refined form of our global hypercontractivity inequality. Along the way, we record various facts needed here and later concerning Markov chains and the Efron–Stein theory of orthogonal decompositions.

5.1 Uncapturability and globalness

This subsection contains the definitions and basic properties of the two key pseudorandomness conditions used in this part. We start with uncapturability, which is the condition that will appear in the regularity lemma in the next subsection. Recall that for $\mathcal{F} \subset [m]^n$ and $\alpha \in [m]^R$ for some $R \subset [n]$, we write $\mathcal{F}[\alpha] = \{x \in \mathcal{F} : x_R = \alpha\}$ and $\mathcal{F}_{R \to \alpha} = \mathcal{F}(\alpha) = \{x \in [m]^{[n] \setminus R} : (x, \alpha) \in \mathcal{F}\}\)$. We also write $D_{R\to\alpha} = \{x \in [m]^n : x_R = \alpha\}$, which is a subcube of co-dimension |R|, which we refer to as a 'dictator' if $|R| = 1$. For a collection of subcubes D, we denote by $|D|$ the union of these $\frac{1}{2}$ subcubes, that is, \bigcup $_{D\in D}D.$

Definition 5.1. We say $\mathcal{F} \subset [m]^n$ is (r, ε) -capturable if there is a set D of at most r dictators with $\mu(F \setminus \mid D) \leq \varepsilon$. Otherwise, we say that F is (r, ε) -uncapturable.

Now we define the stronger (see Claim 5.4) condition of globalness.

Definition 5.2. We say $f : [m]^n \to \mathbb{R}$ is (r, ε) -global if for any $R \subset [n]$ with $|R| \leq r$ and $a \in [m]^R$, we have $||f_{R\to a}||_2^2 \le \varepsilon$. We say $\mathcal{F} \subset [m]^n$ is (r, ε) -global if its characteristic function is (r, ε) -global.

Most of this section will be devoted to the proof of the following small set expansion property for global functions, which is analogous to Theorem [3.3.](#page-8-0) We remark that we will later use Theorem 5.3 to prove that random gluings significantly increase the measure of global families.

Theorem 5.3. *For any* $\lambda > 0$ *, there is* $c > 0$ *such that the following holds for Markov chains* T_i *on* Ω_i with $\lambda_*(T_i) \geq \lambda$ for all $i \in [n]$ and consecutive random states x, y of the stationary chain for the *product chain T* on Ω *. If* $\mathcal{F} \subset \Omega$ *is* (log($1/\mu$), μ^{1-c})-global with $\mu \in (0, 1/16)$ *, then* $\mathbb{P}(x \in \mathcal{F}, y \in$ $(F) \leq \mu^{1+c}$.

We begin by giving two simple relations between uncapturability and globalness that will be useful for us. The first property asserts that globalness implies very strong uncapturability.

Claim 5.4. If $\gamma \in (0,1)$ and $\emptyset \neq \mathcal{G} \subset [m]^n$ is $(1,\mu(\mathcal{G})/\gamma)$ -global, then \mathcal{G} is $(\gamma m/4, \mu(\mathcal{G})/2)$ uncapturable.

Proof. Suppose that D is a set of dictators with $\mu(G \setminus \mid D) \leq \mu(G)/2$. We need to show $|D| >$ $\gamma m/4$. By assumption $\mu(G_{i\rightarrow a}) \leq \mu(G)/\gamma$ for each $D_{i\rightarrow a} \in \mathcal{D}$, so by a union bound

$$
\mu({\cal G})/2 \leq \mu({\cal G} \cap \bigcup {\cal D}) \leq \sum_{D_{i\rightarrow a} \in {\cal D}} \mu({\cal G} \cap D_{i\rightarrow a}) = \sum_{D_{i\rightarrow a} \in {\cal D}} m^{-1} \cdot \mu({\cal G}_{i\rightarrow a}) \leq |{\cal D}| m^{-1} \frac{\mu({\cal G})}{\gamma}.
$$

Thus, $|D| \ge \gamma m/2 > \gamma m/4$, as required. \square

The second property shows that any family $\mathcal G$ with significant measure can be made global by taking small restrictions.

Lemma 5.5. Let $0 \leq \gamma \leq 1$ and $r, m, n \in \mathbb{N}$. For any $C \subset [m]^n$, there is $R \subset [n]$ and $\alpha \in [m]^R$ with $|R| \leq r \log_{\gamma^{-1}} (\mu(G)^{-1})$ *such that* $G' = G_{R \to \alpha}$ *is* $(r, \mu(G')/\gamma)$ -global with $\mu(G') \geq \mu(G)$ *.*

Proof. Starting with $G_0 = G$, for each $i \geq 0$, if G_i is not $(r, \mu(G_i)/\gamma)$ -global, we let $G_{i+1} = (G_i)_{R_i \to \alpha_i}$ for some $R_i \subset [n]$ with $|R_i| \leq r$ and $\alpha_i \in [m]^{\mathbb{R}_i}$ such that $\mu(\mathcal{G}_{i+1}) \geq \mu(\mathcal{G}_i)/\gamma$; such a restriction exists by definition. As all measures are bounded by 1, there can be at most $log_{\gamma^{-1}}(\mu(G)^{-1})$ iterations, at which point we terminate with $G' = G_{p \to \infty}$ with the stated properties. which point we terminate with $G' = G_{R \to \alpha}$ with the stated properties.

5.2 The uncapturable code regularity lemma

In this subsection, we prove the following regularity lemma which approximately decomposes any code into pieces corresponding to uncapturable restrictions.

Lemma 5.6. *Let* $r, k, m \in \mathbb{N}$ and $\epsilon \geq 1/m$. For any $F \subset [m]^n$, there is a collection D of at most *r*^k subcubes of co-dimension at most k such that $F_{R\to\alpha}$ is $(r, \varepsilon\mu(D)^{-1}m^{-k})$ -uncapturable for each $D = D_{R \to \alpha} \in D$ and $\mu(F \setminus \bigcup D) \leqslant 3r^{k+1} \varepsilon m^{-k}$.

Proof. We may assume that F is $(r, \varepsilon m^{-k})$ -capturable; otherwise, the lemma holds with $D =$ $\{[m^n]\}\)$. We apply the following iterative process for $s = 1, \ldots, k$.

- We let D'_{s-1} be the set of $D = D_{R \to \alpha} \in D_{s-1}$ such that $\mathcal{F}_{R \to \alpha}$ is $(r, \varepsilon \mu(D)^{-1} m^{-k})$ -capturable,
where for $s = 1$ we let $D' = D_0 = \{D_{\alpha, \alpha}\} = \{[m]^n\}$ where for $s = 1$, we let $D'_0 = D_0 = {D_{\emptyset \to \emptyset}} = {[m]^n}$.

- For each $D = D_{R \to \alpha} \in \mathcal{D}'_{s-1}$, by definition of capturability, we can fix a set $\mathcal{D}[D]$ of at most r

- We define $D_s = \{D_{(R,i) \to (\alpha,a)} : D = D_{R \to \alpha} \in D'_{s-1}, D_{i \to a} \in D[D]\}.$

At the end of the process, we let $\mathcal{D}'_k \subset \mathcal{D}_k$ be the set of $D = D_{R \to \alpha} \in \mathcal{D}_k$ such that $\mathcal{F}_{R \to \alpha}$ is ϵ)-capturable. We will show that $\mathcal{D} = (D_1 \setminus D') \cup \cup (D_k \setminus D')$ satisfies the requirements of (r, ε) -capturable. We will show that $D = (D_1 \setminus D'_1) \cup ... \cup (D_k \setminus D'_k)$ satisfies the requirements of the lemma the lemma.

Clearly, for all $D \in \mathcal{D}$, we have that $\mathcal{F} \cap D$ is $(r, \varepsilon \mu(D)^{-1} m^{-k})$ -uncapturable, and $|D| \leq r^k$ as we Clearly, for all $D \in D$, we have that $T \cap D$ is $(r, \varepsilon \mu(D) - m$ \rightarrow -incapturable, and $|D| \le r$ as we explore at most many subcubes during the above process. $$
\mathcal{E}_s = \bigcup \{ \mathcal{F}_{R \to \alpha} \setminus \bigcup \mathcal{D}[D] : D = D_{R \to \alpha} \in \mathcal{D}'_s \}.
$$

By definition, $\mu(\mathcal{E}_s) \le \sum_{D \in \mathcal{D}'_s} \mu(D) \cdot \varepsilon \mu(D)^{-1} m^{-k} = |\mathcal{D}'_s| \varepsilon m^{-k}$, so

$$
\mu(\mathcal{F}\setminus\bigcup(\mathcal{D}\cup\mathcal{D}'_k))\leq \varepsilon m^{-k}\sum_{s=0}^{k-1}|\mathcal{D}'_s|\leq r^k\varepsilon m^{-k}.
$$

For the second term in the bound, we note that if $D_{R\to\alpha} \in \mathcal{D}'_k$, then $\mathcal{F}_{R\to\alpha}$ is (r, ε) -capturable, so has measure is at most $r^{\perp} + \varepsilon \le (r+1)\varepsilon$. Thus has measure is at most $r^{\perp}_m + \varepsilon \leq (r + 1)\varepsilon$. Thus,

$$
\mu(\mathcal{F} \cap \bigcup \mathcal{D}'_k) \leq \sum_{D \in \mathcal{D}'_k} \mu(D)(r+1) \varepsilon \leq r^k m^{-k} (r+1) \varepsilon.
$$

We deduce $\mu(\mathcal{F} \setminus \bigcup \mathcal{D}) \leq \mu(\mathcal{F} \setminus \bigcup (\mathcal{D} \cup \mathcal{D}'_k)) + \mu(\mathcal{F} \cap \bigcup \mathcal{D}'_k) \leq 3r^{k+1}\varepsilon m^{-k}.$

5.3 Markov chains and orthogonal decompositions

This subsection contains some further theory of Markov chains, Efron–Stein orthogonal decompositions and a general form of the Hoffman bound for cross-intersecting families in any product space. The results are somewhat standard, but we include details for the convenience of the reader.

Let T be a Markov chain on S with stationary distribution ν . The absolute spectral gap $\lambda_* =$ $\lambda_*(T)$ is

$$
(1 - \lambda_*)^2 = \sup{\{\mathbb{E}(Tf)^2 : \mathbb{E}f = 0, \mathbb{E}f^2 = 1\}}.
$$

Here expectations are with respect to ν . If T is reversible, we can also view λ_{ν} as the minimum value of $1 - |\lambda|$ over all eigenvalues $\lambda \neq 1$. We start with a general lower bound for λ_{α} .

Lemma 5.7. Let T be a Markov chain on S with stationary distribution ν such that $T_{ab} \geq \alpha \nu(b)$ for *every* $a, b \in S$. Then $\lambda_*(T) \geq \alpha$.

Proof. By assumption, $S_{ab} := T_{ab} - \alpha \nu(b) \ge 0$, with $\sum_b S_{ab} = 1 - \alpha$ and $\sum_a \nu(a) S_{ab} = (1 - \alpha) \nu(b)$ α) $\nu(b)$.

If $E f = 0$ and $E f^2 = 1$, then by Cauchy–Schwarz

$$
\mathbb{E}(Tf)^2 = \sum_a \nu(a)(Tf)(a)^2 = \sum_a \nu(a)(\sum_b T_{ab}f(b))^2 = \sum_a \nu(a)\left(\sum_b S_{ab}f(b)\right)^2
$$

\n
$$
\leq \sum_a \nu(a)\left(\sum_b S_{ab}\right)\left(\sum_b S_{ab}f(b)^2\right) = (1-\alpha)\sum_a \nu(a)\sum_b S_{ab}f(b)^2
$$

\n
$$
= (1-\alpha)\sum_b f(b)^2 \sum_a \nu(a)S_{ab} = (1-\alpha)^2 \sum_b \nu(b)f(b)^2 = (1-\alpha)^2.
$$

Now we consider Markov chains T_i acting on Ω_i for $i \in [n]$ and their tensor product $T = T_1 \otimes$ Now we consider Markov chains I_i acting on Ω_i for $i \in [n]$ and their tensor product $I = I_1 \otimes \cdots \otimes T_n$ acting on $\Omega = \Omega_1 \otimes \cdots \otimes \Omega_n$, with transition matrix $T_{xy} = \prod_{i=1}^n (T_i)_{x_i y_i}$. The stationary distribution of T is $\nu = \nu_1 \otimes \cdots \otimes \nu_n$, where each ν_i is stationary for T_i . We will often have $\Omega = [m]^n$ and u uniform but we will also require the general setting $[m]^n$ and v uniform, but we will also require the general setting.

We use the Efron–Stein orthogonal decomposition (see, e.g. [\[27,](#page-46-0) Section 8.3]): for any $f \in$ we use the Efform-Stein orthogonal decomposition (see, e.g. [27, Section 8.5]). For any $f \in L^2(\Omega, \nu)$, we can write $f = \sum_{S \subset [n]} f^{-S}$, where each f^{-S} is characterised by the properties that it only depends on coordina only depends on coordinates in S and that it is orthogonal to any function which depends only on some set of coordinates not containing *S*; in particular, f^{-S} and $f^{-S'}$ are orthogonal for $S \neq S'$. We have similar Plancherel / Parseval relations as for Fourier decompositions, namely $\langle f, g \rangle =$ E have similar riancheter / raiseval relations as for routier decompositions, namely $\langle y, y \rangle =$
 $S \to [f^{-S}g^{-S}]$, so $\mathbb{E}[f^2] = \sum_{S} \mathbb{E}[(f^{-S})^2]$. Explicitly, we let $f^{CJ}(x) = \mathbb{E}_{y \sim y}[f(y) | y_{\overline{J}} = x_{\overline{J}}]$, and

en $\angle S \triangleq [J \quad g \quad J]$, so $\angle [J] = \angle S \triangleq [J \quad J]$. Explicitly, we fet $J \quad (x) = \angle y \sim p[J \lor J]$ $y \bar{J} = x \bar{J}$, and
then, we have $f^{-S} = \sum_{J \subset S} (-1)^{|S \setminus J|} f^{CJ}$ (the inclusion–exclusion formula for $f^{CJ} = \sum_{S \subset J} f^{-S}$). We note the following identity which is immediate from this construction.

Fact 5.8. *For* $S \subset T \subset [n]$, $x \in \Omega_S$ *and* $f \in L^2(\Omega, \nu)$, we have $(f^{-T})_{S \to \nu} = (f_{S \to \nu})^{-T \setminus S}$.

We require the following general form of the well-known Hoffman bound (the uniform case was used in Part [I,](#page-4-0) see Lemma [4.6\)](#page-14-0). We include the proof for completeness.

Lemma 5.9. *Let* $\nu = \prod_{i=1}^{n} \nu_i$ *be a product probability measure on* $[m]^n$ *such that* $\nu_i(x) \le \lambda \le 1/2$ *for all* $i \in [n]$ $x \in [m]$ *Suppose* C_k $C_k \subset [m]^n$ *are cross-intersecting with* $\nu(C_k) = \alpha$, for $i = 1, 2$ *for all* $i \in [n]$, $x \in [m]$ *. Suppose* $\mathcal{G}_1, \mathcal{G}_2 \subset [m]^n$ *are cross-intersecting with* $\nu(\mathcal{G}_i) = \alpha_i$ *for* $i = 1, 2$ *. Then*

$$
\alpha_1\alpha_2 \leqslant \left(\frac{\lambda}{1-\lambda}\right)^2(1-\alpha_1)(1-\alpha_2).
$$

The proof of Lemma 5.9 requires the following estimate.

Claim 5.10. Let U_i be Markov chains on Ω_i for $i \in [n]$ and let U be the product chain on Ω . For claim 5.10. Let U_i be markov chains on Ω_i for $i \in [n]$ and Ω
any $f: \Omega \to \mathbb{R}$ and $S \subset [n]$, we have $||Uf^{-S}||_2 \le ||f^{-S}||_2 \prod$ $_{i\in S}(1 - \lambda_*(U_i)).$

Proof. Since f^{-S} does not depend on variables outside S, we may assume without loss of generality that $S = [n]$. We introduce interpolating operators $U_{\le j} = \bigotimes_{i=1}^{j} U_i \otimes \bigotimes_{i=j+1}^{n} I_i$, where I_i is the identity and $s = U - f^{-1}$ of S for $0 \le i \le n$. It suffices to show $||s|| \le (1 - \frac{1}{n} (U_i))||s||$ or $||$ for $i \in \mathbb$ identity, and $g_j = U_{\le j} f^{-S}$ for $0 \le j \le n$. It suffices to show $||g_j||_2 \le (1 - \lambda_*(U_j)) ||g_{j-1}||_2$ for $j \in$ $[n]$.

We calculate $||g_j||_2^2 = \mathbb{E}(U_j g_{j-1})^2$ by conditioning on $z \in \Omega_{[n] \setminus \{j\}}$, that is,

$$
\mathbb{E}(U_j g_{j-1})^2 = \mathop{\mathbb{E}}_{\mathbf{z} \sim \nu_{[n] \setminus \{j\}}} \left[\mathbb{E}(U_j h_{\mathbf{z}})^2 \right],
$$

where $h_z := (g_{j-1})_{[n] \setminus \{j\} \to z} \in L^2(\Omega_j, \nu_j)$. Note that for each z,

$$
\mathop{\mathbb{E}}_{x \sim \nu_j} \left[h_z(x) \right] = \mathop{\mathbb{E}}_{x \sim \nu_j} \left[(U_{\le j-1} f^{-S})(z, x) \right] = U_{\le j-1} \left(\mathop{\mathbb{E}}_{x \sim \nu_j} \left[f^{-S}(z, x) \right] \right) = U_{\le j-1} 0 = 0,
$$

so $\mathbb{E}(U_j h_z)^2 \le (1 - \lambda_*(U_j))^2 \mathbb{E} h_z^2$. As $\mathbb{E}_z \mathbb{E} h_z^2 = \mathbb{E} g_{j-1}^2$, we get $||g_j||_2 \le (1 - \lambda_*(U_j)) ||g_{j-1}||_2$, as required required. \Box

Proof of Lemma 5.9. For each $i \in [n]$, we consider the Markov chain U_i on $[m]$ with transition probabilities $(U_i)_{xx} = 0$ and $(U_i)_{xy} = \nu_i(y)/(1 - \nu_i(x))$ for $y \neq x$. We claim that

$$
1 - \lambda_*(U_i) \le \frac{\lambda}{1 - \lambda}.\tag{1}
$$

This holds as for any $f \in L^2([m], \nu_i)$ with $E f = 0$ and $E f^2 = 1$, we have

$$
||U_i f||_2^2 = \sum_x \nu_i(x) \left(\sum_{y \neq x} \frac{\nu_i(y)}{1 - \nu_i(x)} f(y) \right)^2 = \sum_x \frac{\nu_i(x)}{(1 - \nu_i(x))^2} \left(\sum_{y \neq x} \nu_i(y) f(y) \right)^2
$$

=
$$
\sum_x \frac{\nu_i(x)}{(1 - \nu_i(x))^2} (\nu_i(x) f(x))^2 \le \left(\frac{\lambda}{1 - \lambda} \right)^2 \sum_x \nu_i(x) f(x)^2 = \left(\frac{\lambda}{1 - \lambda} \right)^2.
$$

Next we note that if $\mathbf{x} \sim \nu$ and $\mathbf{y} \sim U\mathbf{x}$, then $\mathbb{P}(\mathbf{x} \in \mathcal{G}_1, \mathbf{y} \in \mathcal{G}_2) = 0$, as agr $(\mathbf{x}, \mathbf{y}) = 0$ by definition of U, but G_1, G_2 are cross-intersecting by assumption. We can also write this probability as $\langle g_1, U g_2 \rangle$, where $g_1, g_2 : [m]^n \to \{0, 1\}$ are the indicator functions of $\mathcal{G}_1, \mathcal{G}_2$. By orthogonality and Cauchy–Schwarz,

$$
0 = \sum_{S \subset [n]} \langle g_1^{-S}, U g_2^{-S} \rangle = \alpha_1 \alpha_2 + \sum_{S \neq \emptyset} \langle g_1^{-S}, U g_2^{-S} \rangle \ge \alpha_1 \alpha_2 - \sum_{S \neq \emptyset} ||g_1^{-S}||_2 ||U g_2^{-S}||_2.
$$

By Claim [5.10](#page-21-0) and [\(1\)](#page-21-0), we have $||U g_2^{-S}|| \le (\frac{\lambda}{1-\lambda})^{|S|} ||g_2^{-S}||$, so

$$
\alpha_1\alpha_2\leq \sum_{S\neq\emptyset}\left(\frac{\lambda}{1-\lambda}\right)^{|S|}\left\|g_1^{=S}\right\|_2\left\|g_2^{=S}\right\|_2\leq \frac{\lambda}{1-\lambda}\sum_{S\neq\emptyset}\left\|g_1^{=S}\right\|_2\left\|g_2^{=S}\right\|_2.
$$

By Cauchy–Schwarz and Parseval

$$
\left(\sum_{S\neq\emptyset} \left\|g_1^{-S}\right\|_2 \left\|g_2^{-S}\right\|_2\right)^2 \leq \sum_{S\neq\emptyset} \left\|g_1^{-S}\right\|_2^2 \sum_{S\neq\emptyset} \left\|g_2^{-S}\right\|_2^2 = \text{Var}(g_1)\text{Var}(g_2) = \alpha_1(1-\alpha_1)\alpha_2(1-\alpha_2).
$$

We deduce $(\alpha_1 \alpha_2)^2 \leq (\frac{\alpha}{1-\lambda})^2 \alpha_1 \alpha_2 (1-\alpha_1)(1-\alpha_2)$, as required.

5.4 Small set expansion via noise stability

The goal for the remainder of this section is to prove Theorem [5.3](#page-18-0) concerning global small set expansion. We start by reducing it to the case of a particular Markov chain, namely that given by Expansion. We start by reducing it to the case of a particular markov chain, namely that given by
the noise operator, which we will now define. Let $\nu = \prod_{i=1}^n \nu_i$ be a product probability measure
on $\Omega = \Pi^n$. Ω . Fix on $\Omega = \prod_{i=1}^n \Omega_i$. Fix $\rho \in [0, 1]$. We let T_i be the Markov chain on Ω_i with transition probabilities $(T_i) = 0$ + $(1 - \rho)$ that is from any state x we stay at x with probability o or otherwise $(T_i)_{x} = \rho 1_{v=x} + (1 - \rho)v_i(y)$, that is, from any state x, we stay at x with probability ρ or otherwise move to a random state according to $ν_i$. We let T be the product chain on Ω. We also write T = T_ρ . We call T_ρ the *noise operator* when we think of it as an operator on $L^2(\Omega, \nu)$ via $(T_\rho f)(x) =$ $\mathbb{E}_{\mathbf{v}\sim T_{c}x}[f(\mathbf{y})].$

Recall that in Theorem [5.3,](#page-18-0) we want to bound $\mathbb{P}(x \in \mathcal{F}, y \in \mathcal{F})$ for some $\mathcal{F} \subset \Omega$, when x and y are consecutive states of the stationary chain for some product chain U on Ω . The analytic form is to bound $\langle f, Uf \rangle$ where f is the characteristic function of F. We will soon see that this can be bounded by an analogous expression in terms of the noise operator, that is, $\text{Stab}_{\alpha}(f) := \langle f, T_{\alpha} f \rangle$, which is called the *noise stability* of f. For future reference, we note the following estimate, showing that a bound on the noise stability for any given $\rho > 0$ implies one for all $\rho < 1$.

Proof. By Cauchy–Schwarz, we have

$$
\mathrm{Stab}_{\rho}(f) = \langle f, T_{\rho} f \rangle \le \|f\|_2 \left\| T_{\rho} f \right\|_2 = \|f\|_2 \sqrt{\mathrm{Stab}_{\rho^2}(f)}.
$$

The lemma follows by iterating this estimate. \Box

We also need the following well-known formulae for the noise operator and stability.

Fact 5.12.
$$
T_{\rho}f(x) = \sum_{S \subset [n]} \rho^{|S|} f^{-S}(x) \text{ and } \text{Stab}_{\rho}(f) = \sum_{S \subset [n]} \rho^{|S|} ||f^{-S}||_{2}^{2}.
$$

The following lemma reduces showing small set expansion of a general chain U to that of the noise operator, provided that we have a uniform lower bound on the absolute spectral gap in each coordinate.

Lemma 5.13. *Let* $U = \prod_{i=1}^{n} U_i$ *be a product chain on* $\Omega = \prod_{i=1}^{n} \Omega_i$ *with each* $\lambda_*(U_i) \ge \lambda$. Then for *all* $f : \Omega \to \mathbb{R}$ *, we have* $\langle f, Uf \rangle \leq$ Stab_{1- λ} (f) *.*

Proof. We use the orthogonal decomposition $f = \sum_{S \subset [n]} f^{-S}$. We note that $\langle f^{-S}, U f^{-T} \rangle$ can only he non-zero if $S = T$, as $U f^{-T}$ only depends on coordinates in T . Thus be non-zero if $S = T$, as Uf^{-T} only depends on coordinates in T. Thus,

$$
\langle f,Uf\rangle=\sum_{S\subset [n]}\langle f^{=S},Uf^{=S}\rangle\leq \sum_{S\subset [n]}\left\|f^{=S}\right\|_2\left\|Uf^{=S}\right\|_2.
$$

Applying Claim [5.10](#page-21-0) and Fact 5.12 completes the proof. \Box

By Lemma 5.13, to prove Theorem [5.3,](#page-18-0) it remains to prove the following corresponding global small set expansion theorem for the noise operator.

Theorem 5.14. *For every* $\rho < 1$ *, there is* $c > 0$ *such that if* $f : \Omega \to \{0, 1\}$ *is* (log($1/\mu$), μ^{1-c})*-global with* $\mu \in (0, 1/16)$ *, then* Stab_{*o*}(f) $\leq \mu^{1+c}$ *.*

A key ingredient in the proof is the following lemma proved in the next subsection via global hypercontractivity. Firstly we introduce some notation. Lemma 5.15. *For any* $\rho \leq 1/80$, if $f : \Omega \to \mathbb{R}$ is (r, β) -global of degree r, then

$$
\|\mathrm{T}_{\rho}f\|_{4} \leq \beta^{1/4} \|f\|_{2}^{1/2}.
$$

Proof of Theorem 5.14. We start by showing that there exist ρ' , $c' > 0$ such that the statement of the theorem holds with $(\rho' \rho')$ in place of (a, a) . We take $\rho' = 2^{-200}$ and $a' = 1/100$. Firstly of the theorem holds with (ρ', c') in place of (ρ, c) . We take $\rho' = 2^{-200}$ and $c' = 1/100$. \langle f, T_{\rho} f^{\le d} \rangle \le \|f\|_{4/3} \|T_{\rho} f^{\le d}\|_{4} \le \mu^{0.99} \|f\|_{2}^{1/2} \le (\mu^{0.99})^{5/4},
$$

using Lemma [5.15](#page-23-0) and $||f||_{4/3} = \mu(f)^{3/4}$ (as f is Boolean), so $\text{Stab}_{\rho}(f) \le (\mu^{0.99})^{5/4} + \mu^2 \le \mu^{1.01}$.

Now we will deduce the full version of Theorem [5.14,](#page-23-0) that is, for any $\rho < 1$, there is $c > 0$ such that the statement holds. We let $d = \lceil \log(\rho/\rho') \rceil$, $t = 2^d$ and $c = c'/4t$. By Lemma [5.11,](#page-23-0) we have $\text{Stab}(f) \leq ||f||^2$ have $\text{Stab}_{\rho}(f) \le ||f||^{2(1-1/t)} \text{Stab}_{\rho}(f)^{1/t}$. We have $\text{Stab}_{\rho}(f) \le \text{Stab}_{\rho'}(f)$ by monotonicity of $\rho \mapsto$
Stab (f) and $g' \le \rho'$. By globalness $u(f) = \mathbb{E}[f^2] \le u^{1-c}$ so Stab (f) $\le u^{(1-c)(1-1/t)+(1+c')/t}$. $\text{Stab}_{\rho}(f)$ and $\rho^t \leq \rho'$. By globalness $\mu(f) = \mathbb{E}[f^2] \leq \mu^{1-c}$, so $\text{Stab}_{\rho}(f) \leq \mu^{(1-c)(1-1/t)+(1+c^c)/t} =$ $\mu^{1-c+(c'+c)/t} \leq \mu^{1+c}$. $^{+c)/t} \leq \mu^{1+c}$.

5.5 Noise stability via global hypercontractivity

As mentioned in the previous subsection, in this subsection, we will prove the noise stability estimate Lemma [5.15.](#page-23-0) We start with some definitions required to state our global hypercontractivity inate Lemma 3.13, we start with some deminions required to state our global hypercontractivity
inequality. As before, we consider a product measure $v = \prod_{i=1}^{n} v_i$ on $\Omega = \prod_{i=1}^{n} \Omega_i$. For $S \subset [n]$,
we let v_0 denote we let ν_S denote the product measure $\prod_{i \in S} \nu_i$ on $\Omega_S = \prod_{i \in S} \Omega_i$.

Given $f \in L^2(\Omega, \nu)$ with orthogonal decomposition $f = \sum_{S \subset [n]} f^{-S}$ and $T \subset [n]$, the *Laplacian* f according to T is the function $I - f : [m]^n \to \mathbb{R}$ defined by of *f* according to *T* is the function $L_T f : [m]^n \to \mathbb{R}$ defined by

$$
(\mathcal{L}_T f)(x) = \sum_{S \supseteq T} f^{=S}(x).
$$

If T is a singleton $\{i\}$, we denote the Laplacian by L_i . We also require the following alternative, more combinatorial, definition of the Laplacian. We let L_{\emptyset} be the identity operator. For $i \in [n]$, it is easily noted that

$$
(L_i f)(x) = f(x) - \mathop{\mathbb{E}}_{a_i \sim v_i} \left[f(x_1, \dots, x_{i-1}, \mathbf{a}_i, x_{i+1}, \dots, x_n) \right].
$$

Then, for $T = \{i_1, ..., i_d\}$ with $d \ge 2$, one can show that L_T may be defined alternatively by composition, that is, $L_T f = L_{i_d}(L_{i_{d-1}}(... (L_{i_1} f)...))$. It is not hard to check that this definition does not depend on the order in which the Laplacians are taken and is equivalent to the definition via depend on the order in which the Laplacians are taken and is equivalent to the definition via orthogonal decompositions.

In the next subsection, we will prove the following refined version of the global hypercontractive inequality on product spaces from [\[16\]](#page-45-0). For simplicity, we only consider the version required for our purposes, where we bound the 4-norm after applying noise by a function of the 2-norms of the Laplacians.

Theorem 5.16. *Let* (Ω, ν) *be a finite product space. Then for every* $f : \Omega \to \mathbb{R}$ *and* $\rho \leq 1/160$ *, we have*

$$
\left\|T_{\rho}f\right\|^{4}_{4} \leq \sum_{S\subset[n]} \mathop{\mathbb{E}}_{y\sim\nu_{S}}\left[\left\|(L_{S}f)_{S\rightarrow y}\right\|^{4}_{2}\right].
$$

Along with Theorem 5.16, the proof of Lemma [5.15](#page-23-0) also requires the following consequence of globalness for norms of Laplacians.

Claim 5.17. Let $f: \Omega \to \mathbb{R}$ be (r, ε) -global, $T \subset [n]$ with $|T| \le r$ and $y \in [m]^T$. Then $||(L_T f)_{T\to y}||_2 \leq 2^{|T|}\sqrt{\varepsilon}.$

The proof requires the following alternative formula for Laplacians.

Claim 5.18. For any $f: \Omega \to \mathbb{R}$, $T \subset [n]$, we have $(L_T f)(z) = \sum_{S \subset T} (-1)^{|S|} \mathbb{E}_{\mathbf{a} \sim \nu_S} [f(x_S = \mathbf{a}, x_{\overline{S}} = z_{\overline{S}})].$

Proof. We argue by induction on |T|. The claim is immediate from the definition for $|T| = 0, 1$. Let $|T| = d + 1 \ge 2$, and write $T = T' \cup \{i\}$ with $|T'| = d$. Then by definition and the induction hypothesis hypothesis,

$$
(\mathcal{L}_T f)(z) = \mathcal{L}_i(\mathcal{L}_{T'} f)(z) = \mathcal{L}_i \sum_{S \subset T'} (-1)^{|S|} \underset{\mathbf{a} \sim \nu_S}{\mathbb{E}} [f(x_S = \mathbf{a}, x_{\overline{S}} = z_{\overline{S}})].
$$

By linearity and the definition of L_i , we deduce

$$
(\mathbf{L}_T f)(z) = \sum_{S \subset T'} (-1)^{|S|} \underset{\mathbf{a} \sim \nu_S}{\mathbb{E}} \left[f(x_S = \mathbf{a}, x_{\overline{S}} = z_{\overline{S}}) - \underset{\mathbf{b} \sim \nu_i}{\mathbb{E}} \left[f(x_S = \mathbf{a}, x_i = \mathbf{b}, x_{\overline{S \cup \{i\}}} = z_{\overline{S \cup \{i\}}}) \right] \right].
$$

The claim follows as (a, b) is distributed according to $\nu_{S \cup \{i\}}$.

Proof of Claim 5.17. By Claim 5.18 and globalness, we have

$$
\begin{aligned} (\mathcal{L}_T f)_{T \to y}(z) &= \sum_{S \subset T} (-1)^{|S|} \underset{\mathbf{a} \sim \nu_S}{\mathbb{E}} \left[f(x_S = \mathbf{a}, x_{T \setminus S} = y_{T \setminus S}, x_{\overline{T}} = z_{\overline{T}}) \right] \\ &= \sum_{S \subset T} (-1)^{|S|} \underset{\mathbf{a} \sim \nu_S}{\mathbb{E}} \left[f_{T \to (\mathbf{a}, y_{T \setminus S})}(z_{\overline{T}}) \right], \end{aligned}
$$

and taking norm over z and using the triangle inequality yields

$$
\left\|(\mathbf{L}_T f)_{T \to y} \right\|_2 \leq \sum_{S \subset T} \mathop{\mathbb{E}}_{\mathbf{a} \sim \nu_S} \left[\left\| f_{T \to (\mathbf{a}, y_{T \setminus S})} \right\|_2 \right] \leq 2^{|T|} \sqrt{\varepsilon}.
$$

We conclude this subsection with our estimate for noise stability of global functions.

Proof of Lemma 5.15. Suppose $f: \Omega \to \mathbb{R}$ is (r, β) -global of degree r. Let $\rho = 1/80$. By Theorem [5.16,](#page-25-0)

$$
\left\|T_{\rho/2}f\right\|_{4}^{4} \leq \sum_{S\subset[n]} \sum_{y\sim\nu_{S}}\left[\left\|(L_{S}T_{1/2}f)_{S\rightarrow y}\right\|_{2}^{4}\right].
$$

By assumption on f, we only need to consider $|S| \le r$, and for such S by Claim [5.17,](#page-25-0) we have
 $\frac{||(I - f) - ||}{||(I - f) - ||^2} \le 2^{|S|} \sqrt{g}$ for all $y \in \Omega$. As $\frac{||(I - T) - f||^2}{||(I - f) - ||^2} \le 4^{-|S|} \frac{||(I - f) - ||^2}{||(I - f) - ||^2}$ we de $||(L_S f)_{S\to y}||_2 \le 2^{|S|} \sqrt{\beta}$ for all $y \in \Omega_S$. As $||(L_S T_{1/2} f)_{S\to y}||_2^2 \le 4^{-|S|}||(L_S f)_{S\to y}||_2^2$, we deduce

$$
\left\|T_{\rho/2}f\right\|_{4}^{4} \leq \beta \sum_{S \subset [n]} \mathop{\mathbb{E}}_{\mathcal{V}^{\sim \mathcal{V}_{S}}}\left[\left\|(L_{S}T_{1/2}f)_{S \rightarrow \mathbf{y}}\right\|_{2}^{2}\right].
$$

We estimate each summand using Parseval as

$$
\mathop{\mathbb{E}}_{\mathbf{y}\sim\mathcal{V}_{S}}\left[\left\|(\mathbf{L}_{S}\mathbf{T}_{1/2}f)_{S\rightarrow\mathbf{y}}\right\|_{2}^{2}\right] = \sum_{T\supseteq S} 4^{-|T|} \left\|f^{-T}\right\|_{2}^{2} \le \sum_{T\supseteq S} 2^{-|T|} \left\|f^{-T}\right\|_{2}^{2},
$$

so $\beta^{-1} \left\|\mathbf{T}_{\rho/2}f\right\|_{4}^{4} \le \sum_{S\subset[n]} \sum_{T\supseteq S} 2^{-|T|} \left\|f^{-T}\right\|_{2}^{2} = \sum_{T\subset[n]} \left\|f^{-T}\right\|_{2}^{2} = \|f\|_{2}^{2}.$

5.6 Global hypercontractivity

We conclude this section by proving Theorem [5.16,](#page-25-0) via our global hypercontractivity inequality from [\[16\]](#page-45-0). We start by stating this inequality, for which we require some notation. Let $\mathbf{Z}_1, \ldots, \mathbf{Z}_n$ be independent random variables, each with mean 0, variance 1 and $\mathbb{E}[|\mathbf{Z}_i|^4] \leq$ $\frac{1}{2}$ σ_i^{-2} . For $S \subset [n]$, we let $\mathbf{Z}_S = \prod_{i \in S} \mathbf{Z}_i$ and $\sigma_S = \prod_{i \in S} \sigma_i$. We consider multi-linear functions $\sigma_i(\mathbf{Z}_i, \mathbf{Z}_i) = \sum_{\sigma_i \in \mathcal{S}} \sigma_i \sigma_i \mathbf{Z}_G$ with all $\sigma_i \in \mathbb{R}$. For $S \subset [n]$ the discrete deriva *g*($\mathbf{Z}_1, ..., \mathbf{Z}_n$) = $\sum_{S \subset [n]} a_S \mathbf{Z}_S$ with all $a_S \in \mathbb{R}$. For $S \subset [n]$, the discrete derivative of *g* at *S* is $\partial_S g(\mathbf{Z}) = \frac{1}{\sigma_S} \sum_{T \supseteq S} a_T \mathbf{Z}_{T \setminus S}.$ \overline{a}

Theorem 5.19 Theorem 7.1, [\[16\]](#page-45-0). *In the above set up, for* $\rho \in [0, 1/16]$ *, we have* $||T_{\rho}g||_4^4 \le \sum_{\rho \in \mathbb{R}^3} \int_0^2 ||\partial_{\rho}g||_4^4$ $S\subset[n]$ $\sigma_S^2 || \partial_S g ||_2^4$.

We will reduce Theorem [5.16](#page-25-0) to Theorem 5.19 as follows. Suppose that (Ω, ν) is a product space with $\Omega = [m]^n$ and $f \in L^2(\Omega, \nu)$. We will simulate f via a function $g : \{0, 1\}^{nm} \to \mathbb{R}$ which takes *nm* biased random bits $\{z_{i,j}\}_{i \in [n], j \in [m]}$, where the bias of $z_{i,j}$ is $p_{i,j} = \nu_i(j)/4$. Let $\frac{1}{2}$, $\frac{1}{2}$ $\sigma_{i,j} = \sqrt{p_{i,j}(1 - p_{i,j})}$ and $\chi_{i,j}(z_{i,j}) = (z_{i,j} - p)/\sigma_{i,j}$. We note that $\chi_{i,j}$ satisfy the conditions in the above setup, that is, $\mathbb{E}\chi_{i,j} = 0$, $\mathbb{E}\chi_{i,j}^2 = 1$, $\mathbb{E}\chi_{i,j}^4 \leq \sigma_{i,j}^{-2}$. For any $S \subset [n]$ and $x \in \Omega_S$, we define the corresponding character $\chi_i \in [n]$ and χ_i and χ_i and χ_i and χ_i and χ_i an corresponding character $\chi_{S,x} : \{0,1\}^{nm} \to \mathbb{R}$ for $z = (z_{i,j} : i \in [n], j \in [m])$ by setting $\chi_{S,x}(z) = \prod_{x \in [n]} \chi_{S,x}(z)$ The sponting character $\chi_{S,x} : \{0,1\}^n \to \mathbb{R}$ for $z = (z_{i,j}^i : t \in [n], j \in [m])$ by setting $\chi_{S,x}$
 $i \in S$, $\chi_{i,x_i}(z_{i,x_i})$; we also write $\sigma_{S,x} = \prod_{i \in S} \sigma_{i,x_i}$. We then define $g : \{0,1\}^{nm} \to \mathbb{R}$ by setting

$$
g(z) = \sum_{S \subset [n]} \sum_{x \in \Omega_S} \sigma_{S,x} \Big| f^{=S}(x) \Big| \chi_{S,x}(z).
$$

Claim 5.20. $\|\mathrm{T}_{\rho} f\|_{4}^{4} \leq \|\mathrm{T}_{4\rho} g\|_{4}^{4}$.

Proof. Let S be the set of (S_1, S_2, S_3, S_4) where each $S_\alpha \subset [n]$ and $|\{\alpha : i \in S_\alpha\}| \neq 1$ for all $i \in [n]$. Expanding the definition of the left-hand side, we can write

$$
\left\|T_{\rho}f\right\|_{4}^{4} = \mathop{\mathbb{E}}_{\mathbf{x}\sim\nu} \left[\sum_{(S_{1},S_{2},S_{3},S_{4})\in\mathcal{S}} \rho^{|S_{1}|+\cdots+|S_{4}|} f^{=S_{1}}(\mathbf{x})\cdots f^{=S_{4}}(\mathbf{x})\right].
$$

Also, if $S = (S_1, ..., S_4) \in S$ and $x \in \Omega_{\bigcup S}$, then $\mathbb{E}[\prod_{i=1}^{n} S_i]$ $\text{if } S = (S_1, \dots, S_4) \in S \text{ and } x \in \Omega_{\bigcup S}, \text{ then } \mathbb{E}[\prod_{\alpha=1}^4 \sigma_{S_\alpha, X_{S_\alpha}} \chi_{S_\alpha, X_{S_\alpha}}] \ge \prod_{i \in \bigcup S} (p_{i, x_i})$ $16^{-|\bigcup S|}v_{\bigcup S}(x)$, using $\mathbb{E}[(\sigma_{i,j}\chi_{i,j})^q] \geq p_{i,j}/4$ when $q \in \{2, 3, 4\}$, so expanding the right-hand side

$$
\left\|T_{4\rho}g\right\|_{4}^{4}\geq \sum_{S=(S_{1},S_{2},S_{3},S_{4})\in S}\sum_{x\in\Omega_{S}}(4\rho)^{|S_{1}|+\cdots+|S_{4}|}\left|f^{-S_{1}}(x)\right|\cdots\left|f^{-S_{4}}(x)\right|16^{-|\bigcup S|}\nu_{\bigcup S}(x).
$$

As $|\bigcup S| \leq (|S_1| + \cdots + |S_4|)/2$, the claim follows.

To bound $\|\mathbf{T}_{4\rho}g\|_{4}^{4}$, we apply (4 ρ)-biased hypercontractivity (Theorem [5.19\)](#page-26-0), which is valid if $\leq 1/16$ As $\sigma^2 \leq \nu_{\rho}(x)$ we get $\|\mathbf{T}_{\epsilon}g\|_{4}^{4} \leq \sum_{\zeta} \nu_{\zeta}g_{\zeta}$ and $\mathcal{U}(\zeta)$ to bound $||1_{4\rho}g||_4$, we apply (4*p*)-blased hypercontractivity (Theorem 5.19), which is valid if
 $4\rho \le 1/16$. As $\sigma_{S,x}^2 \le \nu_S(x)$, we get $||T_{4\rho}g||_4^4 \le \sum_{S \subset [n], x \in \Omega_S} \nu_S(x) ||\partial_{(S,x)}g||_2^4$. For any $S \subset [n]$ and $x \in \Omega_{\rm S}$, we have

$$
\left\|\partial_{(S,x)}g\right\|_2^2 = \frac{1}{\sigma_{S,x}^2}\sum_{T\supseteq S}\sum_{y\in\Omega_{T\setminus S}}\sigma_{(T,x\circ y)}^2f^{-T}(x,y)^2 \le \sum_{T\supseteq S}\mathbb{E}_{y\sim \nu_{T\setminus S}}\left[f^{-T}(x,y)^2\right],
$$

as $\sigma_{S,x}^{-2} \sigma_{(T,x \circ y)}^2 = \sigma_{T \setminus S,y}^2 \le \nu_{T \setminus S}(y)$. By Fact [5.8](#page-21-0) and Parseval ,we get $\|\partial_{(S,x)} g\|_2^2 \le \|(\mathcal{L}_S f)_{S \to x}\|_2^2$, so

$$
\left\|T_{\rho}f\right\|_{4}^{4} \leq \left\|T_{4\rho}g\right\|_{4}^{4} \leq \sum_{S\subset[n],x\in\Omega_{S}}\nu_{S}(x)\left\|(L_{S}f)_{S\to x}\right\|_{2}^{4} = \sum_{S\subset[n]} \sum_{x\sim\nu_{S}}\left[\left\|(L_{S}f)_{S\to x}\right\|_{2}^{4}\right].
$$

This proves Theorem [5.16.](#page-25-0)

6 MODERATE ALPHABETS

This section contains the proof of our main result Theorem [1.1](#page-1-0) in the case of moderate alphabets, that is, $m > m_0(t)$ is large, but not huge (exponential in *n*). As discussed previously, the strategy is inspired by that for small m , but we must settle for a regularity lemma (Lemma [5.6\)](#page-19-0) that only provides parts which are uncapturable, so the proof of the junta approximation theorem becomes considerably harder.

As in the case of small m , we want to show that the restrictions defining the regularity decomposition form a *t*-intersecting family, so we need to find cross-agreements of any fixed size between two pieces of the decomposition. Again we can reduce to finding cross disagreements by taking restrictions, but this reduction is not immediate as with the stronger pseudorandomness condition in the first part, as uncapturability is not preserved by arbitrary restrictions. We therefore start in the first subsection by proving a 'fairness proposition', showing that random restrictions are unlikely to significantly reduce the measure of a code if it is non-negligible (for which the threshold is such that this is only useful when m is not huge). In the second subsection, we then complete the proof of the main theorem for moderate *assuming the junta approximation the*orem, and of the junta approximation theorem assuming the existence of fixed cross-agreements between non-negligible uncapturable codes.

The idea for finding cross disagreements is to apply the global small set expansion theorem from the previous section to show that for any code of small measure, we can substantially increase its measure by a combination of taking restrictions and applying a gluing operation, in which we pass to a smaller alphabet by randomly identifying symbols in each coordinate. Here we note that any cross disagreement after gluing must come from a cross disagreement before gluing (this is why we will reduce to disagreements, as we do not have any corresponding statement for finding cross-agreements of some fixed non-zero size). By applying Hoffman's bound to the glued codes rather than the original codes, we thus obtain a much stronger bound on the original measures.

We develop the theory of gluings in the third subsection, which we use for measure boosting in the fourth subsection. We then prove the existence of fixed cross-agreements in the final subsection. The concept of globalness is fundamental throughout, as it is needed for measure boosting, and also to maintain some pseudorandomness condition throughout the repeated restrictions needed for measure boosting. Indeed, as uncapturability is not preserved by arbitrary restrictions, we need a careful combination of taking restrictions and upgrading uncapturability to globalness. We must also take care to remove extraneous agreements that may be introduced by these restrictions, which is possible as globalness implies uncapturability, and the definition of uncapturability is designed for this argument.

6.1 The fairness proposition

Here we prove the following 'fairness proposition', analogous to that proved for hypergraphs by Keller and Lifshitz [\[19\]](#page-45-0). The proofs are quite similar, but we include the details for the convenience of the reader.

Proposition 6.1. For any $\delta > 0$ and $s \in \mathbb{N}$, there is $C > 0$ such that for any $\mathcal{F} \subset [m]^n$ with $\mu(\mathcal{F}) \ge e^{-n/C}$, for uniformly random $\mathbf{S} \in \binom{[n]}{s}$ and $\mathbf{x} \in [m]^S$, we have $\mathbb{P}[\mu(\mathcal{F}_{S \to x}) \ge (1 - \delta$ **Proposition 6.1.** For any $\delta > 0$ and $s \in \mathbb{N}$, there is $C > 0$ such that for any $\mathcal{F} \subset [m]^n$ with $\mu(\mathcal{F}) \geq$

Proof. Firstly we consider $s = 1$. For each $i \in [n]$, let $V_i = \{a \in [m] | \mu(F_{\chi_i \to a}) < (1 - \delta)\mu(F)\}$.

We suppose for contradiction that the probability of the complementary event is too large, that is, that

$$
\Pr_{\mathbf{i}\in[n],\mathbf{a}\in[m]}[\mathbf{a}\in V_{\mathbf{i}}] = \frac{1}{nm}\sum_{i=1}^{n}|V_{i}| > \delta.
$$

Let $I = \{i \in [n] \mid |V_i| \geq \frac{\delta}{2}m\}$. We note that $\frac{1}{nm}$
= $[m]^n$ and let $Z = Z(\mathbf{x}) = |\{i \in I : \mathbf{x} \in V_i\}|$. Let $I = \{i \in [n] \mid |V_i| \geq \frac{\delta}{2}m\}$. We note that $\frac{1}{nm} \sum_{i \in I} |V_i| \geq \delta/2$. We consider uniformly random $\mathbf{x} \in [m]^n$ and let $Z = Z(\mathbf{x}) = |\{i \in I : \mathbf{x}_i \in V_i\}|$. Then $Z(\mathbf{x}) = \sum_{i \in I} 1_{\mathbf{x}_i \in V_i}$ is a sum of independe indicator variables with mean

$$
\mathbb{E}Z = \sum_{i \in I} |V_i|/m \geq \delta n/2.
$$

Let \mathcal{F}' be the set of $x \in \mathcal{F}$ such that $|\{i \in I : x_i \in V_i\}| \geq (1 - \delta/2) \mathbb{E}Z$. By the Chernoff bound, $\mu(F') \ge \mu(F) - e^{\Omega_{\delta}(n)} \ge (1 - \delta/2)\mu(F)$, provided $C = C(\delta, s)$ is sufficiently large.
Now we estimate $F := \mathbb{E}[Z(\mathbf{x})]$ lin two ways. By definition of V , we have

Now we estimate $E := \mathbb{E}[Z(\mathbf{x})1_{\mathbf{x} \in \mathcal{F}}]$ in two ways. By definition of V_i , we have

$$
E = m^{-n} \sum_{x \in \mathcal{F}} \sum_{i \in I} 1_{x_i \in V_i} = m^{-n} \sum_{i \in I} \sum_{a \in V_i} |\mathcal{F}_{x_i \to a}| \leq m^{-1} \sum_{i \in I} |V_i| (1 - \delta) \mu(\mathcal{F}) = (1 - \delta) \mu(\mathcal{F}) \mathbb{E} Z.
$$

On the other hand, by definition of $\mathcal{F}',$ we have

$$
E \geqslant m^{-n} \sum_{x \in \mathcal{F}'} (1 - \delta/2) \mathbb{E} Z = (1 - \delta/2) \mu(\mathcal{F}') \mathbb{E} Z \geqslant (1 - \delta/2)^2 \mu(\mathcal{F}) \mathbb{E} Z.
$$

These bounds are contradictory, so the proof for $s = 1$ is complete.

For $s \ge 2$, we proceed by induction. We suppose that the statement holds for any $\delta' > 0$ and δ' = δ /2 and s' = $s = 1$ and consider uniformly random $S' \in \binom{[n]}{s}$ For s ≥ 2, we proceed by induction. We suppose that the statement holds for any $\delta' > 0$ and $s' < s$ with $C = C(\delta', s')$. We let $\delta' = \delta/2$ and $s' = s - 1$ and consider uniformly random $S' \in \binom{[n]}{s'}$ and $\mathbf{x}' \in [m]^{\mathbf{S}'}$. By the induction hypothesis, which can be applied if we choose $C(\delta, s) > C(\delta', s')$,
we have $\mathbb{P}[E(\mathbf{S}' | \mathbf{x}')] > 1 - \delta'$, where $E(\mathbf{S}' | \mathbf{x}')$ is the event that $U(F, \ldots) > (1 - \delta')U(F)$ we have $\mathbb{P}[E_1(\mathbf{S}', \mathbf{x}')] \ge 1 - \delta'$, where $E_1(\mathbf{S}', \mathbf{x}')$ is the event that $\mu(\mathcal{F}_{\mathbf{S}' \to \mathbf{x}'}) \ge (1 - \delta')\mu(\mathcal{F})$.

6.2 Proof summary

In this subsection, we complete the proof of the main theorem for moderate m assuming the junta approximation theorem, and of the junta approximation theorem assuming the existence of fixed cross-agreements between non-negligible uncapturable codes. As m is large, the largest ball is a subcube of co-dimension t , so we can restate our main result for moderate m as follows.

Theorem 6.2. *For any* $t \in \mathbb{N}$ *, there are* $m_0, N \in \mathbb{N}$ *such that if* $m \geq m_0, n \geq N \log m$ *and* $\mathcal{F} \subset [m]^n$ *is* (*t* − 1)-avoiding, then $|F| \le m^{n-t}$, with equality only when *F* is a subcube of co-dimension *t*.

We will prove Theorem 6.2 assuming the following junta approximation theorem.

Theorem 6.3. *For every t, k* ∈ ℕ*, there exist* $C, m_0, N \in \mathbb{N}$ *such that if* $F \subset [m]^n$ *is* $(t-1)$ *-avoiding with* $m \geq m_0$ and $n \geq N \log m$, then there is a *t*-intersecting collection D of at most C subcubes of *co-dimension at most k such that* $\mu(\mathcal{F} \setminus \vert \cdot) \mathcal{D}) \leq C m^{-k}$.

Proof of Theorem 6.2. Suppose $\mathcal{F} \subset [m]^n$ is $(t - 1)$ -avoiding with $\mu(\mathcal{F}) \geq m^{-t}$. By Theorem 6.3, there is a *t*-intersecting collection D of $O_t(1)$ subcubes of co-dimension at most $t + 1$ such that $\mu(F \setminus \mid D) \leq O_r(1)m^{-(t+1)}$. As D is t-intersecting, its subcubes all have co-dimension at least t. Let D' consist of the subcubes in D that have co-dimension t. Then $\mu(\bigcup D \setminus \bigcup D') \le$ $O_t(1)m^{-(t+1)}$. As $O_t(1)m^{-(t+1)} < m^{-t} \leq \mu(F)$ for large m, we must have $D' \neq \emptyset$. Thus, D' consists of exactly one subcube of co-dimension t, say $S = \{x \in [m]^n | x_1 = 1, ..., x_t = 1\}.$

Write $\mu(F_{[t]\to 1})=1-\varepsilon$, where $0\leqslant \varepsilon=m^t\mu(S\setminus F)\leqslant m^t\mu(F\setminus S)\leqslant O_t(m^{-1})$. Suppose for con-
diction $\varepsilon>0$. We claim that $\varepsilon>0^{-2tn/N}$. To see this, fix any $\varepsilon\in F\setminus S$ (using $\varepsilon>0$). Write \mathcal{U} tradiction $\varepsilon > 0$. For $b = a_S$ and $c \in [m]^R$ with $\arg(c, a_R) = 0$, we have $(1^t, b, c) \notin \mathcal{F}$ (since $(1^t, b, c)$ and a agree
on $t = 1$ coordinates) giving $|S \setminus \mathcal{F}| > (m-1)^{n-t-s}$ so $\epsilon > m^{-s}(1-1/m)^{n-t-s} > e^{-tn/N-2n/m}$ on $t-1$ coordinates), giving $|S \setminus F| \geq (m-1)^{n-t-s}$, so $\varepsilon \geq m^{-s}(1-1/m)^{n-t-s} > e^{-tn/N-2n/m} \geq$ $e^{-2tn/N}$, as claimed.

As $\mu(F \setminus S) \ge m^{-t} \varepsilon$, by averaging, we can fix $1^t \ne x \in [m]^t$ with $\mu(F_{[t]\to x}) \ge m^{-t} \varepsilon$. Write $|\{i \in$ $[t] : a_i = 1] = t - 1 - s$ with $s \ge 0$. Consider uniformly random $S \in \binom{[n]\setminus[t]}{s}$ and $\mathbf{y} \in [m]^S$. Let $G = \mathcal{F}_{[t] \to 1, S \to Y}$ and $\mathcal{H} = \mathcal{F}_{[t] \to x, S \to Y}$. By Markov's inequality, $\mathbb{P}[\mu(G) \geq 1 - 2\varepsilon] \geq 1/2$. By Propo-sition [6.1,](#page-28-0) $\mathbb{P}[\mu(\mathcal{H}) \geq 0.9m^{-t}\varepsilon] \geq 0.9$. Thus, we can fix (S, x) so that $\mu(\mathcal{G}) \geq 1 - 2\varepsilon$ and $\mu(\mathcal{H}) \geq 0.9m^{-t}\varepsilon$ 0.9 m^{-t} ε. However, *G* and *H* are cross intersecting, so this contradicts Theorem [2.3.](#page-6-0) Thus, $\varepsilon = 0$, as required. as required. \Box

We conclude this subsection by proving Theorem [6.3](#page-29-0) assuming the following result on crossagreements between uncapturable codes, the proof of which will be the goal of the remainder of this section.

Theorem 6.4. *For any* $s, k \in \mathbb{N}$, *there are* $r, m_0, N \in \mathbb{N}$ *such that if* $m \ge m_0$, $n \ge N \log m$ *and* $A_i \subset$ $[m]^{[n]\setminus R_j}$ are (r, m^{-k}) -uncapturable with $|R_i| \leq k$ for $j = 1, 2$ then there are $x^j \in A_j$ for $j = 1, 2$ *with* $|\{i \in [n] \setminus (R_1 \cup R_2) : x_i^1 = x_i^2\}| = s.$

Proof of Theorem 6.3. Suppose $r, m, N \gg t, k$ and let $F \subset [m]^n$ with $n \ge N \log m$ be $(t-1)$ -avoiding. By Lemma [5.6](#page-19-0) with $\varepsilon=1$, there is a collection D of at most r^k subcubes of co-dimension at most k such that $\mathcal{F}_{R\to\alpha}$ is (r, m^{-k}) -uncapturable for each $D = D_{R\to\alpha} \in \mathcal{D}$ and $\mu(\mathcal{F} \setminus \bigcup \mathcal{D}) \leq$ $3r^{k+1}m^{-k}$. Suppose for a contradiction that D is not t-intersecting. Then there are $D_{R^j\to\alpha^j}\in\mathcal{D}$ for $j = 1, 2$ (not necessarily different) that agree on $t - 1 - s$ coordinates for some $s \ge 0$. Let $\mathcal{A}_1 =$ $\mathcal{F}_{0}^{(n)}$ $T_n I \to \alpha^1 \setminus \bigcup_{i \in R^2 \setminus R^1} D_{i \to \alpha_i^2} \subset [m]^{[n] \setminus R^1}$ and define A_2 similarly. Then A_1 , A_2 are $(r - k, m^{-k})$ uncapturable, so by Theorem 6.4, there are $x^j \in A_j$ with $|\{i \in [n] \setminus (R^1 \cup R^2) : x_i^1 = x_i^2\}| = s$. But

6.3 Gluings and expansion

In this subsection, we introduce our gluing operation and establish a small set expansion property for global codes under random gluings.

Definition 6.5. Let $k < m \in \mathbb{N}$ and $b \ge 1$. A b-balanced gluing from [m] to [k] is a function π : $[m] \to [k]$ such that $|\pi^{-1}(i)| \leq b m/k$ for all $i \in [k]$. We let $\Pi_{m,k}$ denote the set of all such gluings. If $b=1$ (which is only possible when $k \mid m$), we may omit it from our notation.

A b-balanced gluing of $[m]^n$ to $[k]^n$ is a mapping $\pi : [m]^n \to [k]^n$ of the form $\pi(x_1,...,x_n) =$ $(\pi_1(x_1), ..., \pi_n(x_n))$ with $\pi_1, ..., \pi_n \in \Pi_{m,k,b}$. We let $\Pi_{m,k,b}^{\otimes n}$ denote the set of all such gluings; we may again the automorphic for it also from against Γ_n may omit the superscript if *n* is clear from context. For $\mathcal{F} \subset [m]^n$ and $\pi \in \Pi_{m,k,b}^{\otimes n}$, we write $\mathcal{F}^{\pi} = \pi(\mathcal{F}) \subset [k]^n$ $\pi(\mathcal{F}) \subset [k]^n$.

Example 6.6. Consider the gluing π : $[3]^n \rightarrow [2]^n$ where for each $i \in [n]$, we have $\pi_i(1) =$ $\pi_i(2) = 1$ and $\pi_i(3) = 2$. Let $\mathcal{F} = \{x \in [3]^n \mid |\{i \mid x_i = 1 \lor x_i = 2\}| \geq \frac{2}{3}n\}$. Then \mathcal{F} has constant measure in $[3]^n$, but \mathcal{F}^{π} has exponentially small measure in $[2]^n$. measure in [3]ⁿ, but \mathcal{F}^{π} has exponentially small measure in [2]ⁿ.

This example indicates that we should make a careful choice of measure in $[k]^n$ for gluing to be useful.

Claim 6.8. With notation as in Definition [6.7,](#page-30-0) for any $F \subset [m]^n$, we have $v^{\pi}(F^{\pi}) \ge v(F)$.

Proof. For any $y \in [k]^n$, we have

Now we establish global small set expansion for random balanced gluings.

Lemma 6.9. *With notation as in Definitions* [6.5](#page-30-0) *and* [6.7,](#page-30-0) *there is* $c > 0$ *such that the following holds. Let* $s, k, m \in \mathbb{N}$ *be such that* $k = m/s$ *and* $s \geq 4$, let ν *be an s*-balanced product measure on $[m]^n$, and $suppose \, \mathcal{F} \subset [m]^n$ is $(log(1/\mu), \mu^{1-c})$ -global with $\mu \in (0, 1/16)$ *. Then* $\mathbb{E}_{\pi \in \Pi^{ \otimes n}_{m,k} } [\nu^{\pi}(\mathcal{F}^{\pi})] \geqslant \nu(\mathcal{F})^{1-c}$ *.*

Proof. The plan for the proof is to show $\mathbb{E}_{\pi}[\nu^{\pi}(P^{\pi})] \geq \nu(P)^{2}/\langle f, Tf \rangle$, where f is the characteristic Froof. The plan for the proof is to show $E_{\pi}[V(Y)] \geq V(Y) / \sqrt{3} / 3$, where f is the characteristic
function of F and $T = \prod_{i=1}^{n} T_i$ is some product Markov chain on $[m]^n$ with each $\lambda_*(T_i) \geq 1/6$. By Theorem [5.3,](#page-18-0) this will suffice to establish the lemma.

6.4 Boosting measure

In this subsection, we apply the small set expansion properties of random gluings established in the previous subsection to prove the following result, which shows that the measure of any small code can be substantially increased via restrictions and gluings.

Lemma 6.11. *For every* $\varepsilon > 0$, *there is* $C > 0$ *such that for any b*-balanced product measure ν on $[m]^n$ *with* $4 \le b \in \mathbb{N}$ *and* $m > b^{3C}$, *if* $F \subset [m]^n$ *with* $\nu(F) = \mu < 16^{-1/\epsilon}$, *then there are* $\pi \in \Pi_{m,m',b}$ *with* $m' > m/b^{2C+1}$ and $\alpha \in [m']^R$, where $R \subset [n]$ with $|R| < C \log(\mu^{-1})$, such that $\nu^{\pi}((\mathcal{F}^{\pi})_{R \to \alpha}) \geq \mu^{\varepsilon}$.

Proof. We start by applying an arbitrary *b*-balanced gluing $\pi_0 \in \Pi_{m,m_0,b}^{\otimes n}$, where m_0 is the largest power of *b* the tip at most m. Closely, $v_1 := v_0^{\pi_0}$ is belanged. 6.5 Uncapturable codes agree

In this subsection, we prove our cross-agreement result for uncapturable codes, Theorem [6.4.](#page-30-0) As demonstrated in Subsection [6.2,](#page-29-0) this will complete the proof of our main theorem for moderate alphabets. We start with an outline of the proof. We are given two uncapturable codes A_1 and A_2 and need to find a cross-agreement of some fixed size s. Moreover, the coordinate sets may be \mathcal{A}_2 and need to find a cross-agreement of some fixed size *s*. Moreover, the coordinate sets may be slightly different; we have $A \subset [m][n]\setminus R$ with $|R| < k$ for $i = 1, 2$ slightly different: we have $A_i \subset [m]^{[n] \setminus R_j}$ with $|R_i| \le k$ for $j = 1, 2$.

Step 1: Globalness. We would like to restrict to a common coordinate set, but we cannot do so immediately, as uncapturability is not closed under restrictions. We therefore start by upgrading to globalness, while avoiding unwanted agreements. We find a global code \mathcal{A}'_1 obtained from \mathcal{A}_1
by a small restriction. We obtain \mathcal{A}' from \mathcal{A}_2 by removing any agreements with this restriction. by a small restriction. We obtain A'_2 from A_2 by removing any agreements with this restriction,
using uncanturability to see that A' is not negligible, and find a global code B, obtained from A' using uncapturability to see that \mathcal{A}'_2 is not negligible, and find a global code \mathcal{B}_2 obtained from \mathcal{A}'_2
by a small restriction. Then we obtain a global code \mathcal{B}_1 from \mathcal{A}' by removing any agreem by a small restriction. Then we obtain a global code B_1 from A'_1 by removing any agreements with this restriction this restriction.

Step 2: Fairness. By the fairness proposition, we find a common restriction of size *s* by which we obtain non-negligible global codes C_1 , C_2 from B_1 , B_2 . It remains to show that C_1 , C_2 cannot be cross-agreeing.

Step 3: Expansion. We apply measure boosting to find a gluing and restriction so that C_2 becomes some C'_2 with dramatically larger measure. We obtain C'_1 from C_1 by removing any extra
agreements created by the gluing and restriction, and then C'' with non-negligible measure by agreements created by the gluing and restriction, and then C''_1 with non-negligible measure by
applying the gluing that was found for C_2 . We now find a gluing and restrictions for C''_1 to get applying the gluing that was found for C_2 . We now find a gluing and restrictions for C_1'' to get
from it a family C''' with dramatically larger measure than C'' . We then remove these restrictions from it a family C_1'' with dramatically larger measure than C_1'' . We then remove these restrictions as well as apply this gluing on C' to get C'' whose measure not much smaller than that of C' as well as apply this gluing on C'_2 to get C''_2 whose measure not much smaller than that of C'_2 .
By averaging we can apply further restrictions without reducing measures to obtain C_1 . C_2 on a By averaging, we can apply further restrictions without reducing measures to obtain $\mathcal{G}_1, \mathcal{G}_2$ on a common set of coordinates.

Step 4: Hoffman bound. The measures of $\mathcal{G}_1, \mathcal{G}_2$ are so large that they cannot be crossagreeing, so we find a cross disagreement, which corresponds to an agreement of size s in the original codes.

We proceed to the formal proof of Theorem [6.4.](#page-30-0)

Part III: Huge alphabets

This part contains the proof of our main result Theorem [1.1](#page-1-0) in the case of huge alphabets, that is, when $n \le N(t) \log m$, with $N(t)$ as in Theorem [6.2.](#page-29-0) As previously discussed, there are examples showing that a proof strategy based on cross agreements between uncapturable codes cannot work in this setting, so instead we adopt a combinatorial perspective.

7 FORBIDDEN AGREEMENT CONFIGURATIONS

The proofs in this section exploit combinatorial arguments that obtain expansion in measure from a 'shadow' operation, which is analogous (but quite different in various details) to an argument in the hypergraph setting due to Keller and Lifshitz [\[19\]](#page-45-0). This operation requires us to consider more general agreement configurations (which are anyway of interest) even if we only want to find pairwise agreements as in our main result. We introduce these configurations and their interpretation in terms of expanded hypergraphs in the first subsection, and prove an extremal result for configurations. In the second subsection, we define our shadow operation and establish two key properties, namely that a code with a given forbidden configuration (a) has an average shadow with much larger measure and (b) there is some shadow with much stronger uncapturability.

We extend these properties in the third subsection to iterated shadows when there is some forbidden configuration with a 'kernel', that is, some common intersection of all restrictions in the configuration. We apply this theory to prove the junta approximation theorem in the fourth subsection. Then in the final subsection, we complete our proof via a bootstrapping argument based on Shearer's entropy inequality.

7.1 Hypergraphs

When *m* is huge, it is natural to view a code $F \subset [m]^n$ as an *n*-graph (*n*-uniform hypergraph) which is *n*-partite (each edge has one vertex in each part) with parts $V_1, ..., V_n$, where each $V_i =$ $\{(i, a) | a \in [m]\}$, identifying any $x \in [m]^n$ with $\{(i, a) : x_i = a\}$. This setting is most convenient for introducing general agreement configurations in the following definition, as these are a natural partite variation on the well-studied topic of expanded hypergraphs (see the survey [\[26\]](#page-46-0)).

Definition 7.1. An ℓ -configuration is a pair $(\mathcal{H}, \mathcal{P})$ where H is a multi- ℓ -graph and \mathcal{P} = $(U_1,...,U_\ell)$ is a partition of $V(H)$ such that each edge has one vertex in each part. We identify any *H* with its multiset of edges $\{e_1, ..., e_h\}$, so its size $h = |H|$ is its number of edges. We often on it *D* from our notation. The main result of this subsection is the following extremal result for cross containment at constant densities (this suffices for our purposes, so we do not investigate the optimal bound).

Lemma 7.3. *For any* ℓ , $h \in \mathbb{N}$, there is $C > 0$ so that if H is an ℓ -configuration of size h and $\mathcal{F}_1, ..., \mathcal{F}_h \subset [m]^n$ with each $\mu(\mathcal{F}_i) > \varepsilon$, where $n > C \log(\varepsilon^{-1})$ and $m > 2hn/\varepsilon$, then $\mathcal{F}_1, ..., \mathcal{F}_h$ cross *contain* H .

The proof will reduce to the case when H is a matching, as in the following claim.

Claim 7.4. If $\mathcal{F}_1, \ldots, \mathcal{F}_h \subset [m]^n$ with $m > hn/\varepsilon$ and each $\mu(\mathcal{F}_i) > \varepsilon$ then $\mathcal{F}_1, \ldots, \mathcal{F}_h$ cross contain a matching.

Proof. We choose disjoint edges $e_i \in \mathcal{F}_i$ for $i \ge 1$ according to a greedy algorithm. Each choice reduces the density of any \mathcal{F}_i by at most $n/m < \varepsilon/h$, so the algorithm can be completed. reduces the density of any \mathcal{F}_i by at most $n/m < \varepsilon/h$, so the algorithm can be completed. \Box

By a union bound, we can fix Φ and ϕ_1, \dots, ϕ_i so that all $\mu(G_i) > \varepsilon/2$. Then G_1, \ldots, G_h cross contain a matching, so $\mathcal{F}_1, \ldots, \mathcal{F}_h$ cross contain H.

7.2 Shadows

In this subsection, we define our shadow (projection) operation and establish its two key properties mentioned above (boosting measure and strengthening uncapturability).

Definition 7.5. For $F \subset [m]^n$ and $i \in [n]$, the *i*-shadow of F is $\partial_i(F) = \bigcup_{a \in [m]} \partial_{i \to a}(F)$, where $\partial_{i}(F) = F \subset [m]^{n-1}$ For $I \subset [n]$ we let ∂_{i} be the composition (in any order) of $(\partial_{i} : i \in I)$ $\partial_{i\to a}(F) = \mathcal{F}_{i\to a} \subset [m]^{n-1}$. For $I \subset [n]$, we let ∂_I be the composition (in any order) of $(\partial_i : i \in I)$.

The next lemma, analogous to a lemma for hypergraphs in [\[20\]](#page-45-0), shows that shadows have significantly larger measure on average if we forbid a configuration with the following 'flatness' property.

Definition 7.6. The centre of a configuration is the set of vertices contained in more than one edge.

We say that a configuration is flat if each part has at most one vertex in the centre.

Lemma 7.7. *Suppose that* H *is a flat* ℓ -configuration of size h and $F \subset [m]^n$ is H -free, with $n \geq h\ell$. *Then* $|F| \le h \sum_{i=1}^{n} |\partial_i(F)|$.

Proof. Let \mathcal{F}' be obtained from \mathcal{F} by the following iterative deletion procedure starting from $\mathcal{F}' =$ F: if there is any $i \in [n]$ and $y \in \partial_i(F')$ such that at most h choices of $x \in F'$ with $x_{[n] \setminus i} = y$,
then we delete all such $x \wedge ny \in \partial_i(F)$ is considered at most once in this procedure hefore it is then we delete all such x. Any $y \in \partial_i(F)$ is considered at most once in this procedure before it is then we defect an such x. Any $y \in o_i(r)$ is considered at most once in this procedure before it is
removed from the shadow. Thus, the number of deleted sets is at most $h \sum_{i=1}^n |\partial_i(F)|$, so it suffices to show $\mathcal{F}' = \emptyset$.

Suppose for contradiction $\mathcal{F}' \neq \emptyset$. We will show that \mathcal{F} contains \mathcal{H} . We write $\mathcal{H} = \{e_1, ..., e_h\}$, denote the parts of H by $U_1, ..., U_\ell$ and fix $u_i \in U_i$ for each $j \in [\ell]$ so that each vertex of U_i other than u_j is contained in at most one edge. Fix any $x \in \mathcal{F}'$. We will construct $x^1, ..., x^h \in \mathcal{F}'$

We conclude this subsection by showing under the same conditions as the previous lemma, that if a code is uncapturable, then it has some shadow which is significantly more uncapturable. The key point is that the uncaptured measure is increased by a factor $\Omega(m/n)$, albeit at the expense of only considering restrictions that are n times smaller.

Lemma 7.8. Suppose that H is a flat ℓ -configuration of size h and $\mathcal{F} \subset [m]^n$ is H-free, with $n \geq h\ell$. *If* F is (r, ε) -uncapturable, then $\partial_i(F)$ is $(r/n, \varepsilon m/nh)$ -uncapturable for some $i \in [n]$.

Proof. We suppose that each $\partial_i(\mathcal{F})$ is $(r/n, \delta)$ -capturable and show that $\delta \geq \varepsilon m/nh$. By definition, for each $i \in [n]$, there is a collection D_i of at most r/n dictators in $[m]^{[n]\setminus\{i\}}$ such that $\mu(\partial_i(F) \setminus \bigcup D_i) \le \delta$. We let $D = \bigcup_{i=1}^n D_i$ where now we consider each dictator in $[m]^n$.
Then $\mu(F \setminus \square D) \ge \epsilon$ by uncapturability. Applying Lemma 77 to $F \setminus \square D$ noting that each Then $\mu(\mathcal{F} \setminus \bigcup \mathcal{D}) \geq \varepsilon$ by uncapturability. Applying Lemma [7.7](#page-36-0) to $\mathcal{F} \setminus \bigcup \mathcal{D}$, noting that each $\partial_i(\mathcal{F} \setminus \bigcup \mathcal{D}) \subset \partial_i(\mathcal{F}) \setminus \bigcup \mathcal{D}_i$, we have

$$
|F\setminus \bigcup D|\leqslant s\sum_{i=1}^n|\partial_i(F)\setminus \bigcup D_i|\leqslant hn\cdot\delta m^{n-1},
$$

so $\varepsilon \le \mu(\mathcal{F} \setminus \bigcup \mathcal{D}) \le \delta h n/m$, that is, $\delta \ge \varepsilon m/nh$. \Box

7.3 Kernels and iterated shadows

In this subsection, we consider configurations with a non-trivial kernel (intersection of all edges), for which we show that they remain free of some configuration under iterated shadows (as many as the size of the kernel), so the results of the previous subsection on single shadows become correspondingly stronger in this setting. Firstly we introduce some convenient notation.

Definition 7.9. Given an ℓ -configuration H, we write $H \oplus [t]$ for the $(\ell + t)$ -configuration with t additional parts of size 1 where each edge of H is extended to also include the t new vertices.

Given an ℓ -configuration H on v vertices, we let flat(H) be the v-configuration obtained by taking a copy of H with one vertex in each part and adding to each edge e disjoint sets S_e of $v - e$ new vertices.

As the notation suggests, flat (H) is flat, as each of the original vertices gets its own part, and each new vertex is in exactly one edge. To illustrate the construction, consider the 2-configuration H that is a 4-cycle on [4] with parts $\{1, 2\}$ and $\{3, 4\}$ and edges $\{1, 3\}$, $\{1, 4\}$, $\{2, 3\}$ and $\{2, 4\}$. Every vertex of H is in two edges, so in the centre, and so H is not flat. To construct flat(H), which is a 4configuration, we add two new vertices to each edge $\{i, j\} \in \mathcal{H}$, which we call x_{ij}^k for $k \in [4] \setminus \{i, j\}$,
and form nexts U , for $k \in [4]$ where each U , consists of k and the two vertices of the form x^k and form parts U_k for $k \in [4]$ where each U_k consists of k and the two vertices of the form $x_{ij}^{\kappa}.$

Remark 7.10.

- (1) Any (flat) configuration with a kernel of size t may be expressed as $\mathcal{H} \oplus [t]$ for some (flat) configuration H with no kernel.
- (2) If H is flat and contained in H', then H is contained in flat(H').

Lemma 7.11. *For any (flat) configuration* H *, there exists a (flat) configuration* H' *such that for all* $t \in \mathbb{N}$, there exist $m_0, n_0 \in \mathbb{N}$ such that if $\mathcal{F} \subset [m]^n$ with $n \geq n_0$, $m \geq m_0$ is $\mathcal{H} \oplus [t]$ -free, then $\partial_i(\mathcal{F})$ *is* $\mathcal{H}' \oplus [t-1]$ -free for all $i \in [n]$.

Proof. Consider any ℓ -configuration $\mathcal H$ of size h. We let $C = C(\ell + t, h)$ be as in Lemma [7.3,](#page-35-0) $\varepsilon =$ $1/2h$, $n_1 = 2C \log(\epsilon^{-1})$, $m_1 = 3hn/\epsilon$, and then prove the statement for $\mathcal{H}' = [m_1]^{n_1}$, the complete n_1 -partite n_1 -graph with parts of size m_1 . We note that if H was flat initially, then one can take

flat(\mathcal{H}') instead of \mathcal{H}' to preserve flatness, and the correctness follows from the analysis below

Note that if some $\mu(C_i) \geq \varepsilon$, then applying Lemma [7.3](#page-35-0) with $\mathcal{F}_1 = \cdots = \mathcal{F}_h = C_i$, we find a copy of H in C_i . The corresponding $x(y) \in F$ for each y in this copy agrees outside $[n_1]$ in coordinates $T \cup \{i^*\}$ and no others, so we obtain a copy of $H \oplus [t]$ in \mathcal{F} .

Thus, we may assume that each $\mu(C_i) < \varepsilon$. By repeated merging, we can form 'meta-colours' $C'_1, ..., C'_{m'}$, each of which is a union of some of the C_j 's, such that each $\mu(C'_j) \in (\varepsilon, 2\varepsilon)$, so $m' \ge 1/2\varepsilon - h$. By Lemma 7.3 C' or C' cross contain $H \oplus [1]$. The corresponding $x(v) \in F$ for each v $1/2\varepsilon = h$. By Lemma [7.3,](#page-35-0) $C'_1, ..., C'_h$ cross contain $H ⊕ [1]$. The corresponding $x(y) ∈ F$ for each y in this conv agree outside [n,] in coordinates T and no others, so again we obtain a conv of H ⊕ [t] in this copy agree outside $[n_1]$ in coordinates T and no others, so again we obtain a copy of $H \oplus [t]$ in F . in \mathcal{F} .

The following corollary is immediate by iterating Lemma [7.11.](#page-37-0)

Corollary 7.12. *For any (flat) configuration* H and $t \in \mathbb{N}$, there exist $m_0, n_0 \in \mathbb{N}$ and a (flat) con*figuration* \mathcal{H}' *such that if* $\mathcal{F} \subset [m]^n$ with $n \geqslant n_0$, $m \geqslant m_0$ is $\mathcal{H} \oplus [t]$ -free, then $\partial_I(\mathcal{F})$ is \mathcal{H}' -free for
all $I \in ([n])$ *all* $I \in \binom{[n]}{t}$.

We also have the following corollary giving improved estimates on measures and uncapturability of iterated shadows.

Corollary 7.13. *For any flat configuration* H and $t \in \mathbb{N}$ *, there exist* m_0 , $n_0 \in \mathbb{N}$ and $C > 0$ *such that for any* $H \oplus [t-1]$ *-free* $F \subset [m]^n$ *with* $n \ge n_0$ *,* $m \ge m_0$ *,*

- (1) $|F| \leq C \sum_{I \in \binom{[n]}{t}} |\partial_I(F)|,$
- (2) if F is (r, ε) -uncapturable, then $\partial_I(F)$ is $(r/n^i, (m/n)^i \varepsilon/C)$ -uncapturable for some $I \in \binom{[n]}{t}$ *.*

Proof. We argue by induction on t. The base case $t = 1$ is given by Lemmas [7.7](#page-36-0) and [7.8.](#page-37-0) Now suppose $t \ge 2$. By Lemma [7.11,](#page-37-0) there is a configuration \mathcal{H}' depending only on \mathcal{H} such that each $\partial_i(\mathcal{F})$ is $\mathcal{H} \oplus [t-2]$ -free. 7.5 Bootstrapping

We conclude this part with the bootstrapping step that completes the proof of our main theorem for huge alphabets, which we restate as follows.

Theorem 7.15. *For any* $t, N \in \mathbb{N}$ *, there is* $n_0 \in \mathbb{N}$ *such that if* $n \ge n_0$ *,* $m \ge 2^{n/N}$ *and* $F \subset [m]^n$ *is* $(t-1)$ -avoiding, then $|F| \le m^{n-t}$, with equality only when F is a subcube of co-dimension t.

We require Shearer's entropy lemma [\[3\]](#page-45-0), as applied to the projection operators $\Pi_s = \partial_{[n] \setminus S}$ on $\lceil m \rceil^n$.

Part IV: Generalisations and open problems

8 CONFIGURATIONS

In this section, we briefly consider generalisations to excluded configurations (as in the previous section). Our aim is not a systematic study, but just to illustrate the further potential applications of our methods. We start with a general junta approximation result for small alphabets.

Theorem 8.1. *For every* $\eta > 0$ *, configuration* H *and* $m \in \mathbb{N}$ *with* $m > |H|$ *, there are* $J, n_0 \in \mathbb{N}$ *such that if* $F \subset [m]^n$ *is* H -free with $n \ge n_0$, then there is an H -free *J*-junta $\mathcal{J} \subset [m]^n$ such that $\mu(F \setminus T)$ $J \leq n$.

The proof requires the following generalisation of Theorem [3.4.](#page-9-0)

Theorem 8.2. *For every* $h, m \in \mathbb{N}$ *with* $m > h$ *and* $\mu > 0$ *, there are* $\varepsilon, c > 0$ *and* $r \in \mathbb{N}$ *such that if* $\mathcal{F}_1, \ldots, \mathcal{F}_h \subset [m]^n$ are (r, ε) -pseudorandom with each $\mu(\mathcal{F}_i) > \mu$ and $(x_1, \ldots, x_h) \in ([m]^n)^h$ is *uniformly random subject to* $\arg(r_i, x_{i'})=0$ *whenever* $j \neq j'$ *then* $\mathbb{P}(x_1 \in \mathcal{F}_1, ..., x_h \in \mathcal{F}_h) > c$.

The proof of Theorem 8.2 is the same as that of Theorem [3.4,](#page-9-0) except that the absolute spectral gap condition must be replaced by a more general condition on 'correlated spaces', which specialises to our situation as follows. Given $f, g : [m]^h \to \mathbb{R}$ with $\mathbb{E}f = \mathbb{E}g = 0$ and $\mathbb{E}f^2 = \mathbb{E}g^2 = 1$, such that f depends only on the first coordinate and g does not depend on the first coordinate, and $\mathbf{a} \in [m]^h$ with distinct coordinates chosen uniformly at random, we need to show that $E f(a)g(a) < 1$. By considering the equality conditions for Cauchy–Schwarz, it is not hard to see that this holds when $m > h$.

Proof of Theorem 8.1. The proof is the same as that of Theorem [2.1,](#page-5-0) except that instead of showing that I is t-intersecting, we need to show that I is H-free. To see this, we suppose for a contradiction that $\mathcal J$ contains $\mathcal H$ and show that $\mathcal F$ contains $\mathcal H$. We suppose $\mathcal H = \{e_1, ..., e_h\}$ is an ℓ -configuration with parts $(U_1,..., U_{\ell})$ realised by $x^1,..., x^h \in J$. By relabelling, we can assume that *H* is realised on coordinate set [ℓ], that is, for any $j, j' \in [h]$ and $i \in [n]$, we have $x_i^j = x_i^j$

Next we will turn to large alphabets, for which we require the following generalised Hoffman bound.

For moderate alphabets, we have the following generalised form of our earlier lemma on fixed agreements between uncapturable families: we show that uncapturable families cross contain any configuration.

We conclude this section with a junta approximation result for configurations over large alphabets, where for simplicity, we restrict attention to flat configurations with no kernel. For this case, we obtain a result that is analogous to our junta approximation result in terms of 'crosscuts' of expanded hypergraphs in [\[16\]](#page-45-0).

Firstly we give the appropriate definition of the crosscut for configurations. Let H be an ℓ configuration of size h. The crosscut $\sigma(\mathcal{H})$ is the minimum number s such that there is a collection \bigcup D of s co-dimension 1 subcubes such that $\mathcal{H} \subseteq \bigcup \mathcal{D}$, among all collection D of s co-dimension 1 and each edge $e \in \mathcal{H}$ is contained in exactly one subcube in D. Note that $\sigma(\mathcal{H}) > 1$ if and only if H has no kernel, that is, $K(\mathcal{H})=\emptyset$.

Theorem 8.5. *For every* $\eta > 0$ *and flat configuration* H with no kernel, there is C such that if m, n > *C* and F ⊂ $[m]$ ^{*n*} is *H*-free, then there is a collection *D* of fewer than σ (*H*) subcubes of co-dimension *1* such that $\mu(F \setminus \bigcup D) \leq \eta/m$.

Proof. Let $\mathcal{F} \subset [m]^n$ be \mathcal{H} -free, where $\mathcal{H} = \{e_1, \dots, e_n\}$ is an ℓ -configuration with parts (U_1, \dots, U_ℓ) and $K(\mathcal{H})=\emptyset$.

Firstly we consider moderate alphabet sizes, that is, $n \ge N \log m$, with $m, N \gg h, \ell$. We can assume that F is (r, m^{-2}) -capturable, with $h, \ell \ll r \ll m$; otherwise, we find H by Theorem [8.4,](#page-42-0) applied with all $A_j = F$. Thus, we find a collection J of at most r subcubes of co-dimension
l such that $u(F) | J \ge m^{-2}$. Let D be the set of $D = \sigma J$ such that $u(F) \ge n/2r$. Then 1 such that $\mu(F \setminus \bigcup \mathcal{J}) \leq m^{-2}$. Let D be the set of $D_{i \to \alpha} \in \mathcal{J}$ such that $\mu(F_{i \to \alpha}) \geq \eta/2r$. Then $\mu(\bigcup \mathcal{J} \setminus \bigcup \mathcal{D}) < \eta/2m$, so it suffices to show $|\mathcal{D}| < \sigma(\mathcal{H})$.

Suppose for a contradiction that $|D| \ge \sigma(H)$. Then by definition, D contains a copy of H, without loss of generality realised on coordinate set $[\ell']$ by injections $\phi_i : U_i \to V_i = \{(i, a) : a \in [m]\}$ such that for each $j \in [h]$, there is $D_{i^j \to a^j} \in D$ such that $\phi_{i^{j'}}(e_j \cap U_{i^{j'}}) = (i_{j'}, a^{j'})$ if and only if $i - i'$ $j = j'.$

Let C be the set of $i \in [\ell]$ such that U_i contains a vertex in the centre of H. For $i \in C$, let c_i be the vertex of U_i in the centre of H (which is unique by flatness). We may assume for any $i \in C$ that D either contains $D_{i\to\phi_i(c_i)}$ or does not contain any $D_{i\to a}$; indeed, if D does not contain $D_{i\to\phi_i(c_i)}$, then each $D_{i\to a}$ is $D_{i\to a}$ for at most one $j \in [h]$, so we can obtain an alternative realisation replacing ϕ_i by $\phi'_i : U_i \to V_{i'}$ for some new $i' \in [m]$, where $\phi'_i(v) = (i', a)$ whenever $\phi_i(v) = (i, a)$.
Let *I* be the set of all $i \in [n]$ such that *D* contains some *D*. We claim that we can fix *v*.

9 CONCLUDING REMARKS

An open problem is to decide whether our main theorem holds for the binary alphabet $m = 2$. Here our junta approximation method cannot work, as the (conjectural) extremal examples are not juntas: they are balls depending on all coordinates. Despite this, it is still plausible that a result can be obtained by a stability method, by adapting the methods of [\[18\]](#page-45-0) in proving stability for Katona's intersection theorem.

Another natural open problem is to obtain an infinitary version of our main theorem. Say $A \subset$ \mathbb{R}^n is $(t-1)$ -avoiding if it contains no pair x, y with $|\{i : x_i = y_i\}| = t-1$. What is the maximum possible Hausdorff dimension of A? At first, one might think that the answer is $n - t$, and that this would follow from our theorems for large finite alphabets via a standard limiting argument if one assumes that A is closed. One must make some assumption on A for any non-trivial result, as there are pathological examples of $A \subset \mathbb{R}^n$ of Hausdorff dimension *n* in which any distinct *x*, *y* have $x_i \neq y_i$ for all $i \in [n]$. However, even when A is closed, there are some surprises. For example, although it is not hard to see that a 1-avoiding set in $[m]^3$ has size $O(m)$, there is a closed 1-avoiding set $A \subset \mathbb{R}^3$ with Hausdorff dimension 2: this can be achieved by $A = \{(x, f(x), f(x)) : x \in [0, 1]\}$ for a suitably pathological continuous function f .
